# YESTERDAY'S MAIL.

We glean a few items of intelligence from papers received by this mail.

UNITED STATES .- The New York Commercial Advertiser, contains the following remarks relative to the large quantities of bread stuffs which will in a short time reach that port for shipment.

"I have just returned from a visit West, and travelled over the State of Ohio in every direction, desire to present some things which I saw and which are worthy of attention. I had supposed that at this time Ohio would be drained of its provisions, and that the farmers drained of its provisions, and that the farmers would have already taken everything in the shape of breadstuffs to market. Judge of my surprise when I discovered vast stacks of wheat unthreshed, and corn unshelled in cribs, by the way side. The produce of the former crops in Ohio is far from being marketed as stated, and if other States west are in the position of Ohio, then must our country indeed become the granary of the world.

"On the road from Delaware to Mansfield which is the terminus of the Sandusky rail road in a south eastern direction, the road was lined with waggons innumerable, all loaded with wheat or corn; so that six miles beyond Mansfield the stage coach in which I was,

At Mansfield, Sandusky, and every intermediate station, the produce collected was immense. So also at Cleveland, Erie and Buffalo. At one time on the lake there were forty three vessels in sight navigating those waters, and employed in their downward trips in transporting breadstuffs to market."
