The papers from other parts of the Province make mention of the severity of the weather. The following is copied from the St. John Courier of Saturday

"The thermometer, yesterday, in this City, stood at 17 degrees below the cypher—being the coldest we have experienced this winter. At Fredericton, on Monday, Wednesday, and Thursday last, the thermometer ranged from 23 to 25 degrees below 0."

SHIPWRECKS .- Letters from Cuba speak of dreadful gales and shipwrecks in that quarter. The ship Creole, of New Orleans, from Bordeaux, with 158 passengers, was wrecked near Neuvitas, and 43 persons lost, including the captain. Three other vessels were lost in the same vicinity. Nothing was known of their

The Swedish ship Brenza was cast away on the Brazilian coast, near Bahia; and some 30 lives lost, together with a large amount of property. It is stated that a number of the crew were actually starved to death.

ANOTHER STEAMER .- We have much aatisfaction in being enabled to state that there is every prospect of a Steam Ferry Boat being speedily placed on our river, to ply between Chatham and the opposite side. The Shareholders purpose meeting on Tuesday next, after which we shall be enabled to speak more fully on the subject.

FROM HONDURAS .- By the arrival at New York of the brig Montserrat, Capt. Gray, from Belize, papers of that place to the 19th of December have been received. The latest papers mention that recent gales had caused great destruction of property, and it was feared of life also, to the southward of that place. The rivers had been unusually high. At Sitee the river rose thirty feet, covering the plantations, and drowning cattle.

Horses, trees, &c., were swept away by the torrent. So sudden was the rise of water, that many persons had difficulty in escaping to the high lands.

Mexico.-Papers received by the mail yesterday, put us in possession of the following later intelligence from the seat of war in this country :-

Intelligence has been received of the forces under Generals Wool, Twiggs, and Quitman, having joined General Worth at Saltillo, while the supposed advance of Santa Anna's army is now said to be only that of his "corps of observation." servation.

The recapture of Los Angelos, in Upper Cahfornia, by the Mexicans, appears to be confirmed; though instead of a "massacre of 150 Americans," as at first reported in the Mexican papers, not one American was killed, and only three wounded. There appears to have been but few Americans there.

Commodore Perry, having captured Laguna.

The accounts by this arrival relieve all apprehensions of inamediate collision with the enemy. The report that Santa Anna was advancing on Saltillo with a large force, turns out to be an exaggeration at the least. The Mexican troops which were seen, are pronouneed only to have been a large foraging party, Santa Anna remaining, with the body of his troops, at San Luis Potosi. Gen. Taylor, in his counter-march from Victoria, met on the second day, Colonel May of the dragoons, bearing this version of the alarm, and Gen. Taylor ing this version of the alarm, and Gen. Taylor accordingly again turned on his steps, and advanced towards Victoria. The forces in Saltillo have been considerably strengthened. The Kontucky and Ohio regiments under General Butler, have marched there; and the Kentucky cavalry were to march en the 28th ult.—Montarey, also, under the command of Colonel Garland, is considerably reinforced.

Mexican papers have been received in New York, containing the message of President Sa-las at the opening of the Congress, and the re-ply of that body thereto. General Santa Anna was chosen President of the Republic, until the constitutional period for a popular election. The Message says:—

"The illustrious General Santa Anna, by an act of his life which will cover him with imperishable honor, refused to take upon himself the supreme command, but marched at once to San Luis, where, in the space of a few weeks, he united and organized an army of 20,000 men, sections of which have already thrown themselves before and encountered the enemy. On their part, the government of the 20,000 men, sections of which have already thrown themselves before and encountered the enemy. On their part, the government of the United States, pledged as they are to 'conquer a peace,' having given orders to General Taylor that he should advance. Thus, then, another excounter between the two nations will soon take place; but however it terminates this action will neither be the last, nor decisive. Our country being invaded and occupied in a manner the most unjust atrocious, our honor and the welfare ef our children obliges us to sustain the struggle, however prolonged, until we shall arrest the mortal ambition of our Northern neighbours, and make sure the position of our race upon this hemisphere.

"Acting on these principles, the Government has not desired to receive any propositions of peace; the question of war remains submitted to your decision, and the Government can only recommend to Congress the urgent necessity of aiding the army with all the resources necessary for the campaign."

THE BRITISH MAIL .- The hands in our office remained comparatively idle all day yesterday, as we confidently anticipated a British mail. Time wore on, and about half-past seven in the evening we were gratified with the announcement that the Courier had arrived, and brought with him the British January mail. The Postmaster soon discovered, however, that a very large portion of the mail had been sent astray. All the letters and papers for the Northward were missing, as well as the letters for Chatham, and the greater portion of the papers. The whole of the Novascotia mail was also wanting. Our friends in Newcastle were more fortunate-all their English letters and papers came to hand. Our share of the mail amounted to three London papers, bearing date the 5th, 12th and 26th December. From this scanty stock we have gleaned every thing worth extracting, but the intelligence obtained is not important.

This piece of carelessness, or negligence, or whatever else it may be called, will be seriously felt by our neighbours in the neighbouring Counties, as it will deprive them of the opportunity of answering their letters by the February mail, which may prove of serious consequence to many; and should the mistake be discovered in time to forward the missing bags on Friday, our merchants will have but the short period of time elapsing between the arrival and departure of the mail to answer their correspondents. Should there be a further delay, they also will be placed in the same awkward dilemma as the inhabitants of Gloucester and Restigouche.

There is no period of the year at which a similar blunder would be so seriously telt, and we trust the head of the department will cause a strict investigation of the circumstance, that the guilty party may receive a just reprimand.

Not receiving a Halifax paper, we are unable to state the day the steamer arrived, or the length of her passage.

Our Courier travelled rapidly with the mail. He left the Bend at 5 o'clock in the morning, and reached Chatham about 7 in the evening, having in the space of 14 hours traversed nearly 100 miles.

POSTCRIPT.

To the attention of T.C. Allan, Esq., we are indebted for a Halifax paper of Saturday. The Steamer Hiberoia arrived there on the morning of Friday last. His Excellency the Earl of Elgin was a passenger. We see nothing of special moment in the extracts given from the British papers.
