Mr. Partelow had no objection to have this number printed, and the Speaker gave Clerk directions accordingly. The despatch being read at the Clerk's table, Mr. Fisher said that as he had the honor of moving the address of that house, which brought down the despatch, he would give notice that at an early day he should move a resolution to the effect that the principles contained in that despatch be immediately adopted by that House.

The Sun states that the seats of the Hon. gentlemen above named, on the acceptance of office, according to the Responsible system, became immediately vacated—and writs for new Elections were accordingly asked for.

The Yarmouth Herald states, that on the same morning that the shock of an Earthquake was felt in the vicinity of Halifax, there were two slight shocks of an earthquake in that town and vicinity. One of them was just before day break—the other, about 8 o'clock.

CANADA.—Our papers inform us the Legislature of this Province is summoned to meet for the despatch of business on the 25th inst. The Quebec Chronicle of the 4th inst. contains a list of the members returned for the new Assembly, which shew a large number against the present Government.

The same paper announces the death of the Hon. John Neilson, long connected with the press of Canada. He was in his 71st year.

Toronto has suffered from an extensive fire, we give the particulars below:—

Great Fire at Toronto.—About half past one o'clock in the morning of the 1st inst. a fire broke out at Toronto, in the block bounded on the north by Colborne, on the West by Church, and on the South by Front-Streets, which was not subdued until the whole block, with the exception of the south-east angle, was demolished.

From Mexico.—Rumours of Peace, and Attempted Insurrection at the Capital.—The steamship Edith, from Vera Cruz, has arrived at New Orleans, bringing advices to the 20th ult.

Rumours of peace, and of an attempted insurrection in the City of Mexico were circulating at Vera Cruz.

The peace rumours are founded upon the fact that the Mexican Commissioners had submitted a plan or treaty of peace, embracing the propositions offered by Mr. Trist at Tacubaya.

The World published at Guadalajara, says in its number of the 17th January, that news had reached Mazatlan of 500 California Rangers having attacked the American posts of "Lapane" and San Jose, and that they had defeated them and burnt both places on the 2d ult. Three American vessels were despatched from Mazatlan to render all possible assistance to the Americans.

P. E. ISLAND.—The Legislature of this Colony met for business on the 11th inst. The Halifax Guardian gives the following brief synopsis of the Governor's speech on the occasion:—

After announcing his appointment to the Government of the Island, and congratulating them on the present meeting, the Lieut. Governor proceeds to direct their attention to matters of much importance to the present and future welfare of the colony—the state of the Island currency, the future management of the post office, the enactment of a law to prevent the recurrence of such sickness and distress, as prevailed among the unfortunate Irish emigrants last year; and the revision of the laws regulating elections.
