During her absence the house from some cause took fire, and melancholy to relate, the whole four children perished in the flames. The neighbors seeing the smoke hurried to the spot but it was too late—the father and mother of the children arriving just as the roof fell in, thereby witnessing the burning up of all they held dear in life. The feelings of the parents were wrung to madness by this awful visitation, and it was with difficulty the neighbors restrained them from rushing in and sharing the fate of their offspring. The authorities of the parish speedily convened a meeting among the neighbors, and did everything to alleviate the sufferings of the parents. The resident medical gentleman, Dr Lafurge, after examining the remains, could not discover that they came to their deaths by unfair means, and the jury returned a verdict of accidental death.—Quebec Gazette.
