Frightful Explosion.—Nine Hundred Lives Lost.—A most dreadful catastrophe, attended with fearful loss of life, occurred at Constantinople on the 25th ult. The Turkish three decker, Neiri Sheyket, ship of the line, 120 guns, was totally destroyed by an explosion of its powder magazine. Six captains, fourteen lieutenants, and Commodore are ameng the deaths. Altogether upwards of 900 lives were lost.

The London Advertiser says that a number of the aristocracy, who have been in the habit of attending the Puseyite churches at the West End, have resolved to absent themselves from these places for the future.

Among the stated hearers of the Rev. Mr Bennett. of St. Paul's, Hyde Park, are two Cabinet Ministers, and among occasional hearers there was a third: all have withdrawn.

The country has now quite a wintry appearance. The ground is hard and sprinkled over with snow, and indeed it seems as if we over with snow, and indeed it seems as if we were to have a little more. It was snowing at Montreal last night, and we are not usually very much behind our sister city in anything. The navigation cannot remain open much longer. There are now only about a dozen vessels to put to sea. We had an arrival, however, this morning, the brig Albert, from Sydney.—Quebec Chronicle. Nov. 22.

Schooner Perseverance, of Miramichi, was lost at St. Peter's Bay, P. E. Island, on Thursday, 21st November, and two of the Crew, Robert Ingraham and Richard Malcolm, were unfortunately drowned. The hull and cargo were to be sold for the benefit of all concerned. Four other vessels went ashore during the gale at the same place.

A Norwegian vessel, the Nicholai Jean, Captain Martin, and another vessel that had been loading at Richibucto, appeared off Esbeen loading at Kichibate, appeared on Es-cuminac on the 29th November. The for-mer had lost both anchors and cables. Both vessels stood to the eastward, apparently bound for Britain.

The Pictou Chronicle reports a large number of shipwrecks on the Nova Scotia coast, during the storm of the 21st ult.
