The Fugitive Slave Bill, recently passed by Congress, by which persons who have escaped from slavery, may be rescued, and restored to their owners, is creating a great excitement throughout the non-slaveholding States. Meetings have been held by the colored population in Massachusetts, New York, and other places, at which resolutions were passed, pledging themselves to resist any attempt to deprive them of their liberty, by force of arms, if necessary. Large numbers of fugitive slaves, who have been residing in the free States for many years, have left for Canada. A negro named Hamlett, doing business in New York for a length of time, has been seized by his former master, and carried into slavery. He was not allowed to see his wife and children before leaving.

The first ticket for Jenny Lind's Concert at Providence, sold for \$650. A large party went from Quebec to Boston to hear her sing. The New York Tribune says : We understand that just before leaving New York, Mdlle. Lind sent \$1000 to the Swedish Episcopal Church, being now erected at Chicago. This generous donation was promptly made, on learning of the embarrassments of the Church.

COUNTY OF KENT .- There are now lying at the wharf of L. P. W. DesBrisay, Esq., at Richibucto, four vessels of different nations, namely, a Russian, Prussian, Norwegian, and English. This is something new.

The bark Commodore, from Boston, is daily expected at Shediac. She has on board nine convicts, recently discharged from the hulks at Bermuda. They were not allowed to land at Boston, and took passage in the Commodore.

NEW COUNCILLORS. - The Fredericton Head Quarters of Wednesday last says-" It is rumored among those likely to know something of the matter, that the vacancies in the Legislative Council of this Province have been, or are immediately to be, filled. Madam rumour has bestowed legislative honors on Dr. Wilson, Mr Brown, and Mr Wark, all members of the late House of Assembly .---Neither of these gentlemen possess the qualification which was once thought necessary for a Legislative Councillor, i. e., having been rejected by the people-for neither offered for re election as members of the Assembly."
