He came out to Halitax, N. S., in 1788, and arrived here shortly afterwards, above sixty years ago. His memory will be long cherished and revered by a large circle of al-fectionate and grateful friends. As a father, he trained up his children in the way that they should go, and exemplified in practice the precepts he inculcated with pa-rental fidelity and family prayer. As a friend, he was warm, kind, could constant and rental fidelity and family prayer. As a friend, he was warm, kind, cordial, constant and steady, and continued faithful into the death. As a professed Christian, he was an Israelite indeed, in whom was no guile. His was the religion of the Bible, settled in all its bear-ings on the Divine Redeemer. He had the ornament of a meek and quiet spirit, in the sight of God, of great price. He was distin-guished for faith and patience, habitual cheer-fulness and equanimity of temper, spirituali-ty of conversation, and consistency of cha-racter. Amid domestic trials, which pressed racter. Amid domestic trials, which pressed heavily upon him, by the late event of the death of his wife, about six months before his own, and that of his son James, about his own, and that of his son James, about seven weeks ago, resigned to the will of God, and sustained by the right band of His righ-teousness, he was emabled to say, "the Lord gave, and the Lord hath taken away, blessed be the name of the Lord," As an enlightened, a conscientions and steadfast member and worthy Elder of the Presbyterian Church, he firmly adhered to truth. He was no high, but liberal in his

truth. He was no bigot, but liberal in his sentiments, and of a public spirit; he loved all, of whatever denomination, who loved the Lord Jesus Christ in sincerity, rather rejoic-ing to hear of converts to Christ, than of proselytes to party. The noblest ambition of his heaven-born soul, was to promote the or his neaven-bord sour, will to promote the honor, and celebrate the praises of his exalted and reigning Prince and Saviour, and always hailed new tidings of perpetuating triumphs of the Cross in the success of the Gospel, and of Christian missions over the whole earth.

The venerable old gentleman was an honor to the Bench of Magistrates in this County, and reflected great credit on his civil office as a Justice of the Peace, whose functions he discharged with impartiality and faithfulness. The memorials of his intelligence, principle and worth, stand high in the estimation of the and worth, stand night in the estimation the community, as exhibited in his public and private character, excellent and useful life, and happy and peaceful death, on his way to the future state of glory and blessedness; as unchangable as complete. ## SECOND EDITION.

EUROPEAN NEWS .- We copy below a summary of European News, received by the Collins steamer Arctic, which vessel put into Halifax for coal.

From the Halifax Church Times, of Friday last.

The United States Mail Steamer Arctic, Captain Luce, came into this port, rather un-expectedly, this morning, short of coal. She has been out 13 days, having left Liverpool on the 11th, and brings Liverpool dates of on the 11th, and brings Liverpool dates of that day. The Arctic has 32 passengers. She carries sufficient coal for 18 days, but recklessness in its use, and desperate head winds, have shortened the consumption, and the consequence is, her arrival at the very convenient Port of Halifax. We have been obliged by the kindness of

the second officer of the ship, Mr Ayre, with the loan of a complete file of English papers from the 5th to the 11th, instant. The French Ministry had been compelled

to resign, owing to a succession of defeats. A new ministry might be formed, but as it involves the dismissal of General Changar-nier, which is insisted upon by the Presi-dent, it is very doubtful if it would be sus-tained. French affairs seem to be approachtained. ing a crisis. Upon the whole, the news is of a decidedly

unimportant character. The papers with which we have been favored, have scarcely a paragraph relative to the Papal aggression. the excitement on which appears to have entirely subsided, in so far as outward demon-stration is concerned. there. The Gomer Polski announces that the affair of the Hongarian refugees has been finally arranged. America has offered them an as-sylum, which they have accepted, and has arranged. America has offered them an as-sylum, which they have accepted, and has undertaken to provide for their wants; the cotomin Government pays their expenses from thence to America. This arrangement was proposed by the Ottoman Government and acceled to by England and America. GERMANY.—Hamburg is now occupied by Prussian troops only, in case the duchies propose an active resistance to the proceed-ings of Prussia and Austria.

propose an active resistance to the proceed-ings of Prussia and Austria. Berlin, Jan. 7.—The reports of the impend-ing resignation of the Minister of Commerce assumed greater probability. The policy of Protection is now wholly rejected by the go-vernment. It is not unlikely that Prussia and Austria will agree on a scale of differential duties, which will be a greater advance on the former prohibited system, though Austria cannot at present command the establish-ment, of one general tariff of duties for all Germany. The resignation of the Navarres cabinet in Spain is again reported. It is announced that the Dublin and Gal-way Railway will be opened to travellers on

UNITED STATES.-A new Postage Bill has passed the Honse of Representatives, establishing three cents as the Postage on each letter not exceeding half-an-ounce in weight, and the same for each additional half-ounce, without regard to weight.

Great Fire at New Orleans.—The St. Char-les Hotel—the pride of the South — with Klapp's Church in Poydras Street, and other Anapp's Church in Poydras Street, and other buildings, were destroyed by fire on the 18th instant. The loss is estimated at not less than half a million of dollars. It is reported that several lives were lost in the conflagration
