The quality and state of the Wool affect the work very materially. When the Wool is clean, well picked, and left at the Machine, or with any of the undermentioned Agents, it will be Oiled and Carded for Four Pence per pound. If properly greased with good, clean, sweet grease or oil, to the satisfaction of the subscriber, it will be Carded for Three Pence per pound. The following gentlemen will act as agents, to take in Wool, until the 15th September next, viz: Johnson & Mackie, John Dixon, at the Ferry, and M. M. Sargeant, Newcastle. The subscriber will have the Wool conveyed to and from once every eight or ten days.
