The distance from Halifax to Quebec by the Bend and Boiestown, through the centre of New Brunswick, is five hundled and nine-ly five miles. This route was rejected by the Commissioners, because in crossing New Brunswick through its centre, the line would cut the whole of the range of hills which tra-verse the Province from North East to South West, at right angles, and thus presenting the most serious engineering difficulties; be-ides, if the ruilroat were constructed on this Vest the Province from North East to South West, at right angles, and thus presenting the most serious engineering difficulties; be-iides, if the ruitoat were constructed on this joute, it would present such severe grades and steep inclines as would render it very expen-sive work, and greatly increase the cost of traffic. Mr Wilkinson having advocated this line, on the ground of its being shorter than the Eastern route, his observations were re-ferred to Major Robinson, who has replied at length in a very able despatch, lately trans-mitted to this Province, which we shall no-tice hereafter. Major Robinson proves most clearly the superiority of the Eastern route, as well from its greater cheapness as from its being better calculated both for heavy traffic and increased speed when completed; and although it is forty miles longer, yet in rail-way calculation it would be the shoiter of the two, because trains could be run over it in less time than on the central route, with the barme power, owing to the more level charac-ter of the county. Another route has been proposed from Ha-liax to Shediac, thence to this City, and up the valley of the Saint John, by Fredericton and Woodstock to Quebec. The length of this route is as follows:—Halifax to Shedi-et, 150 mlles; Shediac to St. John, 105 miles; St. John to Fredericten 65 miles; Frederic-tion to Woodstock, 62 miles; Woodstock to the Grand Falls, 71 miles; Grand Falls to River du Loup, 106 miles; Du Loup to Que-bec, 110 miles. Total 669 miles. Besides the greater length of this route. It must be borne in wind that it offers more seri-ous engineering difficulties than any other in this Province. From Woodstock to Grand Falls the difficulties, (within British territo-yy) are so great as to preclude the possibility of ponstructing a line in that direction, ex-cept at a most enormous expense; while from the Grand Falls to the St. Lawrence there is most difficult and unfavorable ground to encounter, and no pass has yet been dis-covered through the Temiscou

there is most difficult and unfavorable ground to encounter, and no pass has yet been dis-covered through the Temiscouata mountains. The St. Andrews and Quebec Railway Com-pany have always been aware of these almost insuperable difficulties, and the original sur-vey of their line diverged from the valley of the St. John at Woodstock, and thence pro-ceeded in a north westerly direction across American territory to Quebec. To this line The St. Andrews Company yet look as their moute to Quebec ; and in 1850, the Company applied to the Legislature of Maine, by peti-tion, for leave to earry their line from Wood-stock to Quebec across the north eastern sec-tion of Maine. This application was dismis-ed in a very summary manner by the Legis-lature, the House at once ordering that the Company should have " leave to withdraw their Petition."


