flamee. The parapet wall has expanded so as to render its removal necessary. At one time it was feared that the domes, as well as the roof of both houses, would catch fire.

The fire is said to have caught from a defective flue or gas pipe, though many suppose it to have been the work of an incendiary.

Nothing was destroyed but the wing containing the library, and the external appearance of the building remains unchanged, save the blackeved window of the library portice.

Aboutla dozen watchmen were stationed in

About a dozen watchmen were stationed in the building, and it is thought that had they attended to their duties, the flames might have been put out before serious damage was

done.
This is the second library of Congress that has been destroyed by fire. The original library was burnt by the British troops, at their sack of Washington, in 1814. The agovernment then purchased the private library of President Jefferson, which formed the nucleus of the one just destroyed.

FROM JAPAN.

FROM JAPAN.

The Hamburg brig Rose, on a trip from Singapore to San Francisco, met with a severe typhoon, was disabled and obliged to put back to the nearest port for repairs. This happened to be one of the Islands of Japan. Captain Anderson states that the name of the village is Nipaking, and this visit of a foreign vessel is believed to be the first ever made to that place. Of this, however, it would be impossible to state with accuracy. No sooner had Captain Anderson dropped anchor than his vessel was surrounded with three hundred Japanese boats, which guard was kept up, with alternate relief, until she sailed from the harbor. After some little difficulty he was allowed to go singly on shore, when an escort of sixty men conducted him with great watchfulness a short distance throthe principal street. On landing he found all the warts and believed.

On landing he found all the marts and public places closed, althowhile leaving his vessel he had seen extensive market places thrown open, and an appearance of animated trade going on. Every thing presented a blank wall to him, and he was not permitted to gratify his curiosity in the slightest particular. Yet he was treated great respect and kindness, and furnished with sixty men to prosecute repairs on his

The population of Nipaking he estimates at 25,000 souls. A very large police force was constantly on duty, and during his stay three or four thousand from a neighboring island (probably sent for by the authorities of Nipaking) arrived, who kept a diligent watch on the strangers. In their treatment of them they were reserved and courteous, and evidently desired to hasten him from their dently desired to hasten him from their

When his vessel was ready for sea, they ment for labor, and without pushing investi-gations farther he left the place.
