CALIFORNIA.

Great Fire at Sacramento-2500 Buildings destroyed-Loss of Life.-The mail steamer llinois acrived at New York on Sunday night lest, with 540 passengers, and \$2,100,000 in gold on freight, and \$400,000 in the hands of the passengers. The dates from San Fran-cisco, are to the 16th November. The Ame-rican steamer City of Pittsburgh was des-troyed by fire at Valparaiso on the 24th No-

The fire at Sacramento city destroyed 2500 buildings, among them almost every one of value in the city, and over \$10,000,000 worth of property. Great distress prevailed among the women and children. Contributions were opened to relieve the sufferers in the principal towns. San Francisco paired in 10 deur pal towns. San Francisco raised in 10 days \$30,000.

After the fire in Sacramento City, doughnuts were selling at a dollar each; coffee ty cents a cup. Thousands are wandering around knowing no shelter for night, and the amount of suffering will be inconceiva-

Eight or ten lives had been lost by the Sacramento fire. The wind was blowing a gale at the time, and the fire raged with fearful rapidity. Three hundred and fity build-ings, many of them being brick, were erected in nine days, and hundreds of others were ra-

pidly going up.

The fire at San Francisco was on the evening of the 14th. The Whig estimates the loss at from \$150,000 to \$200,000.

Fires had occurred at Stockton and Sonora under suspicious circumstances.

They are taking down buildings in San Francisco and removing them to Sacra-mento, so great is the demand for tene-ments at the latter place, in consequence of

the fire.

The loss by the fire in Marysville is estima. ted at \$150,000.

#### NOVA SCOTIA.

Important from T. basco-By the arrival at New York of the brig Captain, John Cousins, master, from Tobago, we are informed that the city is overflowing with water. The excitement is very great, as boats can easily proceed up the streets. The water in the custom house was from two to three feet deep.

A civil war had broken out in Tobasco, in which a large number of citizer opposed to the present government had taken up arms and succeeded in taking two small towns. There have been two battles, in which about 400 government troops have been killed. It is supposed that as soon as the water subsided, there would be a general outbreak, as the Mexican troops were soon expected there.

From Mexico.—The Battle Between The Mexicans and French Fillibusters.—The New York Herald has private advices from Acapulco, which give the subjoined particulars of the battle between General Blanco and Count Boulton:
The Mexicans are reported to have number-

ed about 2,000, whilst the French army un-der Court Boulbon, were only 250 stong. 15 of the French were killed, while the Mexican loss was very large. Count Boulbon then marched on Hermosilla, the capital of Sonora, and declared it independent, and was, with a handful of men, encamped within one league of Guayamas when the vessel which brought this news left Acapulco.

From the Cape of Good Hope.—Philadelphia Dec. 8.—By the United States sloop of war St. Mary's, Cape Town papers to Oct. 26th, 25 days later, have been received.

The papers contain details of the Kaffir war. Collisions between the troops and Kafnrs are mentioned, but no decisive battles have been fought. A band of rebels at Albany colony were hunted by a force under Commander Barry; five or six of the rebels were killed, and five guns were captured.

Captain Hearne and two men of the 12th regiment had been killed by the Kaffirs.

MINING REGULATIONS.

1. Owners of Land may apply for a Lease of the Mining Rights reserved by the Crown in the Grants of Such Lands, and the same will then be offered at public Auction, after sixty days notice. The application to be accompanied by evidence of the title, and by a plan of survey of the Land mode by a Plan. a plan of survey of the Land made by a De-

2. The term of the Lease will be twenty five years, and will contain a clause of renewal, or that the Government may resume and take the improvements at a valuation, to be made by Arbitrators mutually chosen by the Surveyor General for the time being, and by

the Lessee or his Assigns. 3. The upset preference price to be five pounds, and payment to be made within one one shilling per chaldron on coal, and five per cent on the value of all other minerals raised, to be paid quarterly, on the first days of January, April, July and October, each year, to the Receiver General, or an Agent for that

to the Receiver General, or an Agent for that purpose to be appointed by the Government. The statement on which such payments are to be made, to be on oath.

4. That if the Lessee or his Assigns shall not actually raise coal or other mineral to the value of one hundred pounds, from his ground within any one year after the first, during the continuance of the Lease, the same shall become forfeited.
