ICE IN THE GULF .- It would appear by the following paragraph, copied from the Halifax Sun, that there is not much ap-pearance of the navigation of the Gulf being open at an early period this season. The wind has prevailed here for upwards of three weeks from the Eastward: this must tend to keep the ice in shore, and while it so remains we cannot expect any favorable change in our weather.

" We are informed that the Gulf of St Lawrence, stretching as far as the eye can reach from the highest land on the north and eastern shores of Cape Breton, is packed with massive ice. Large flows, and keavy, with here and there a 'berg,' extend at intervals along the whole sents shores of the Province, which is they nearly girled with increase. which is thus nearly girdled with ice; and until westerly gales with a strong southerly current, prevail for several days consecutively, we may expect that 'winter will continue to linger in the latitude of spring.'
