#### NORTH WEST BRIDGE.

The meeting called by the High Sheriff to take this matter into consideration, came off on Thursday last. We were absent in the County of Kent at the time, but understand that the meeting was a very large one, and that the most perfect unanimity prevailed. There was but one opinion as to the utility of the undertaking. Over £600 in stock was subscribed, and the projectors of the enterprise entertain no doubt but that the whole amount will be speedily taken up. The four Members of the County were present, and each pledged himself to use his best endeavors to procure from the Legislature a grant in favor of the work. The plan submitted by Mr Crocker was highly approved of, and his estimate of the amount required for its erection appeared satisfactory. The Secretary has sent us a report of the proceedings of the meeting, which we have much satisfaction in publishing.

At a large and influential meeting of the inhabitants of the County of Northumberland, held at the Court House, in Newcastle, on Thursday, the 16th day of September, 1852, called by a Requisition to the High Sheriff of the County, for the purpose of taking into consideration the many advantages that must accrue to the inhabi-tants from the erection of a Bridge across the North West Branch of the Miramichi River.

#### EUROPEAN NEWS.

The following monthly Report of the Liverpool Timber Market, is taken from Willmer & Smith's European Times;

Since the 1st February, the supplies to this port of North America Colonial Wood have brought in 173 vessels, viz., 35 from Quebec, 58 from St. John, N. B., and 80 from other ports, which have occupied a tornage of 106, 414; during the same time last year there arrived 185 vessels, the tonnage being 120,644. The average amount for the like time in the four years previous to this has been 89,722 tons. From the North of Europe 39 vessels. tons. From the North of Europe 39 vessels, 11,824 tons, wood laden, have arrived; whilst for the like time last year, 44 vessels, 13,287 tons, arrived; the average of four years being 11,016 tons.

Hitherto the supply this season of Square Timber has been considerably under the usual quantity, whilst that of Deals has greatly exceeded an average, prices of the former have consequently been on the advance for some time, and those of the latter have given way. They appear, however, now to have arrived at more steady rates. The stocks are moderate, the demand for consumption is considerable, and there seems to be confidence in the maintenance of our present currency. tenance of our present currency.

THE CROPS .- From all parts of the Province report speaks favorably of the harvest prospects. The Fredericton vapers write in the most glowing language of the crops in that quarter, and predict a harvest of unusual plenty. Papers from other parts of the province also speak in the same strain. In our own locality, however, we can hardly say as much. The unusual dryness of the early part of the season, has, we believe, to a great extent injured the grain crop, in many localities, and the hay crop we understand to be below an average. The recent rains, however, we hear, have given great impetus to the potato, which promises to be over an an average crop, and to make up the deficiency in the grain har-
