

dy, introduce those shameful and reckless grants which they countenance and support as individual representatives. Would they recommend a grant of £250 to a Telegraph Company because their line does not pay? or £20 to a stageman for a dead horse? or £30 to an alien for thirty years' alien tax, paid by law. Do not make a preference in favor of one person, merely because his business brings him in contact with, and requires him to *save* the members: we cannot think that that creates a right to *save* the Province. We do not attempt to defend the statute which imposes such a tax, but if it is unjust, the law should be repealed; and if money collected under it is to be refunded, let it be to all who have paid the tax, without respect to persons, and that will take a sum not far from £30,000. Then there is the Queen's Printer's Bill for an old balance of £526, rejected by former Committees, and refused, we believe, by more than one House. Yet they open the chest, and he must be paid: grants by thousands for almost every imaginable; purpose and to cap the climax of the matter, after *contracting* for the reporting of the debates, give £50 each to two additional Reporters, unconnected with the contract. One of these, we understand, ought to have had the contract. He is admitted to be an excellent Reporter, and made the lowest tender, we believe. Yet he did not get it, and we imagine he would not have got a grant had he stood alone. He was a Liberal—this was no doubt the reason.

We might multiply such examples of the distribution of the public money, without end, but will drop the subject for the present.

In justice to our representative, Mr J. M. Johnson, we must state, that, though standing almost alone, he opposed this wilful extravagance; and we can understand the attempts made by members of the Government to brow-beat and bully him, and the efforts of the Executive organs to write him down. His conduct is appreciated by his constituents, and although he is unfortunately too often unsuccessful, let him not be discouraged. If the rest of the Northern members had taken a similar stand, what might they not have accomplished?

We must have Biennial Parliaments and Vote by Ballot, before corruption can be successfully resisted.

NOVA SCOTIA.

Our readers will recollect that the Committee to whom the petition of Major Norton, asking pecuniary aid towards maintaining a steam communication between Quebec and Pictou, reported unfavorably. The subject was taken up in the Assembly on motion of Mr Hall, and by a large majority referred to the Committee of Supply.

The subject of an Elective Legislative Council has been discussed in the Upper Branch of the Legislature, and the correctness of the principle, sanctioned by a majority of one.

The Railway Bills have been at length introduced and passed. Of the delay there could be a tale disclosed, which would not reflect credit on the parties interested.

The Halifax Sun says:

"Among the passengers by the Niagara, hence for Liverpool, was the Hon. Mr Chandler, delegate from the New Brunswick Executive to the Colonial Office. The Hon. Gentleman will probably be followed by the Provincial Secretary of Nova Scotia. The absence of Earl Grey from the Colonial Office may serve to relieve Mr Howe of some feeling of embarrassment which the presence of His Lordship might have created."

TO THE MIRAMICHI NEWS ROOM.

ST. JOHN, Monday, April 5, 7 P. M.

Supply closed to-day. Among the last votes passed were £547 to Mr Simpson, for printing the Reports; £150 for the enlargement of the Emigrant Hospital at St. John; £1,100 to the Commissioner of Public Buildings, for the expense of the addition to the House, fittings, repairs of Government House, &c.; grants for a wharf in Queen's and King's Counties. An application for £100 for the promotion of Temperance was rejected; also applications for Temperance Halls, &c.

A Resolution passed giving the use of the Province Buildings for the Provincial Exhibition.

Resolutions were sent down from the Council to address the Queen to allow an armed Steamer to coast between Pictou and Quebec. Not yet considered.

The Bill to amend the Fishery Bill passed.

The steamer Baltic arrived at New York this evening, with four days later dates. Cotton lower; grain market dull; Wheat 2d, Corn 6d, and Flour 1s lower. No other news.

Tuesday, 7 o'clock, P. M.

The Bill amending the Act for the encouragement of Agriculture passed both branches.

The Bill amending the Fishery Law passed the Council, with an amendment that angling for Salmon be allowed until September.

The Scrutiny Committee have voted, and declared the seat vacant.

Mr Barberie's Bill relating to Timber Berths was postponed till next session.

The several appropriations passed the Council. Many Bills postponed. Nothing else of importance.

Wednesday, 7 o'clock, P. M.

The Post Office Bill passed to-day. It fixes salaries, mode of payment of Couriers, and all matters relating to the Post Office Department are arranged by the Committee.

Some resolutions passed; one pledging the House to appropriate a sum of money for a wharf at Sackville, next year.

The account for Contingencies caused some discussion. The amount for the Assembly allowance is £1,384. Of this £316 to Mr Beek for stationery, and to Mr Chubb £166. Several addresses, &c.

The Legislature was prorogued at three o'clock.

Thursday, 7 o'clock, P. M.

The steamer Africa arrived at New York at 7 o'clock last evening, with 66 passengers, and dates to the 28th ult. Cotton declined one-eighth of a penny. Corn dull and drooping. Flour 6d lower.

Parliament will be dissolved soon after Whitsuntide.

The French Assembly meets on the 29th There was much speculation regarding the President's Message. French refugees are hunted out of almost every petty state in Europe. It is said the Empire would shortly be proclaimed.

Saturday, 7 o'clock, P. M.

Since the close of the Legislature, there is little of interest to report. The weather is cold, with the wind N. E.

There have been several arrivals the last two days; among them are the ships Cornelia from Leith, barks Indus from Hull, St. John from Glasgow, and several from the United States and West Indies.

There is nothing of any public interest by the Africa at New York on Wednesday as already announced.

There is a decided determination on the part of the Austrian Government to prevent the circulation of the Bible in that Kingdom.

In the British Parliament, Mr Hume moved to bring in a bill extending the elective franchise in England and Wales to every man of the age of 21 years not subject to any mental or legal disability. After a long debate the motion was lost by 244 nays, to 89 yeas. Between 9000 and 12,000 engineers have signed the employer's proposition, and returned to their work. In France arrests continue to be made. In many cases without any reason assigned.
