

the gallant officers who took part in that war to her person and government, they deemed it inexpedient at the present time to recommend Her Majesty to accede to the prayer of the address.

Another despatch stated that Her Majesty had been pleased most graciously to receive the address on the subject of reciprocal trade between the Province and the United States.

The third despatch, on the Clergy Reserves, by far the most important, was received by the House with evident signs of satisfaction. We publish this despatch elsewhere and recommend it to the perusal of our readers. We would particularly draw attention to the care which has been taken by the Colonial Secretary to Deprecate any intention on the part of Her Majesty's Government, to interfere with the international affairs of the province, and to point out that it is only on the broad constitutional principle that Canadians have the best right to legislate on their own matters.

Mr Morin gave notice of his intention to move for a call of the House for the 1st March, to take up the Representative bill—*Quebec Gazette*.

FREDERICTON MAIL.

Serious Disturbance at Sherbrooke.—Last night we received a telegraphic communication from our Montreal correspondent, stating that, on the 15th instant, a great disturbance prevailed about the railroad, near Compton—the Sheriff's officers sent to arrest the offenders were most savagely beaten by the mob. The officers returned the following night, well armed, but were again severely treated; one officer's skull is fractured; another had some ribs broken.

The railway labourers are said to amount to near four hundred. The cars are destined for Montreal were detained by the Sherbrooke authorities to convey a requisition for troops from Montreal. It is feared that the chief perpetrators have commenced beyond the Province line.—*Quebec Mercury*.

NEW BRUNSWICK.

The Queen's Answer to our Fishery Address.—The following answer to the Address of our public meeting to the Queen respecting the Fisheries, was received by the Lieutenant Governor per last English Mail, and transmitted to Charles Johnston, Esq., High Sheriff of this County, who acted as Chairman to said meeting—received in town Yesterday morning.

Downing Street, January 22d, 1853
Sir—I have to acknowledge the receipt of your Despatch No. 2 of the 1st inst., enclosing an Address to the Queen, from the Inhabitants of the City and County of Saint John, on the subject of the Fisheries.

I have laid this Address before the Queen who was pleased to receive it very graciously; and I am commanded by Her Majesty to acquaint you that the prosperity of the North American Provinces being one of the main objects which Her Majesty has in view, in entering into a Treaty for the adjustment of the Fishery Question, the interests of New Brunswick will not fail to receive careful consideration in any negotiation with the Government of the United States. Reciprocity.—We have been favoured with the perusal of a private letter from Washington, in which it is stated that very great efforts are to be made to secure the passage of Mr Seymour's bill respecting reciprocal trade and the fisheries, before the rising of Congress on the 4th March. There will be a most determined opposition to certain parts of the bill; but the anxiety for a settlement of the fishery question, it is expected, will induce many members to waive minor objections, in order to a settlement of that matter. The time is very short, however, and the bill may be defeated by factious delay.—*St John New Brunswick*.

NOVA SCOTIA.

City Rem.—On Sunday morning a violent storm was experienced in the City, but in the evening it was clear, cold, and pleasant—barring the bad walking, in consequence of the depth of snow.

Preparations are already being made to commence the erection of the new Market House. The Building will be of brick, faced with granite, and no doubt will prove an ornament to the city. The corner stone will be laid in July next by his Worship the Mayor, with full masonic ceremonies.

The favorite Steam Packet Sir John Harvey has been sold in Boston to a company engaged in the Australian trade, and it is said that she will shortly proceed on her first voyage to that distant country.

Death on board the America.—Mr Kitchen, of Pictou, owner of the Barque Aurora, (for Australia,) who was a passenger in the America, died during the passage on Wednesday, 9th inst., 4th day after leaving Liverpool and was interred the following day, with the usual maritime services.—*Halifax British North American*.

CANADA.

Railways in Canada.—The N. York Herald states that Mr Stevenson, the celebrated Engineer who constructed the famous Tubular Bridge over the Menai Strait, is now on his way to Canada, to examine the site for a similar Bridge across the St Lawrence at or near Montreal.

The Canadian papers state that Mr Jackson and his associates have intimated to the Canadian Government their readiness to relinquish the Provincial Railway loan of £3000 per mile, provided that Government will make a liberal grant to aid the construction of the Tubular Railway Bridge at Montreal.

UNITED STATES.

Great excitement prevails in Mobile among real estate holders. Much of the valuable property in that city is derived from the title of a firm residing there many years ago—Messrs Pantou, Leslie & Co.—which is alleged to be defective. Two hundred ejectment suits have already been brought. Recent accounts represent that there is a fearful state of excitement among those interested. Property to an immense amount, say to millions, is involved.

NEW BRUNSWICK.

HOUSE OF ASSEMBLY

The following were adopted as standing Rules in the Session of 1851:—

37th.—That no Bill of a private nature, or Petition for money or relief, shall be received by the House after the fourteenth day from the opening of the Session, both inclusive; and that the Clerk of this House do, one month previous to the meeting of the Legislature, cause fifty printed copies of this Rule to be sent to each of the Clerks of the Peace in the several Counties for distribution, and cause the same to be inserted in the Royal Gazette, and two Newspapers in such County where Newspapers are published.

38th.—That this House will sustain no application for allowances to Teachers of Common or Parish Schools, unless it shall be certified by at least two Trustees of Schools for the Parish where such School has been taught, shewing the time actually taught—the Teacher to be licenced—the cause why such Teacher was not certified to the Sessions in the ordinary way—and that such Teacher was not compelled to discontinue his or her School on account of any improper conduct.
