neighbourhood. The smallest of these is about 300 tons burthen—the largest 1200—average of the whole 16, say 800 tons. The demand for ships next year, it is said, will be greater than has ever yet been known to our builders, which will certainly be cheering news to the Province .--Morning News.

WEST INDIES.

Jamaica .-- We have files of the Kingston papers to the 11th instant.

Two shocks of an earthquake were felt at Kingston, early on the morning of the 9th inst. Both of them were very slight.

The Kingston Journal, on authority of a letter from a member of the Provincial Le-

gislature, on a visit to England, states that Lord Harris, the present Governor of Trinidad, has accepted the Governorship of Jamaica, and that it is expected he will assume the government before the end of the present year.

The Jamaica papers furnish some particulars of the late earthquake in St. Jago de Cuba, on the 26th November, a brief mention of which has been previously made. The following is an abridgement of a translation from El Redactor de Santiago, published in the Kingston Standard.

An earthquake as violent and of longer continuance than that which occurred on the 20th of August last took place soon after 3 o'clock this morning.

According to the best calculations we have made, the direction of the earthquake was from north to south.

The destruction is great. We can only at this moment afford our readers a brief detail of the disasters that have emanated from the event.

[Here follows a long list of buildings destroyed and mjuree.]
The mercantile establishments have suf-

fered much and great loss is sustained. In fact, so destructive an earthquake has never before been felt in Cuba.

In the house attached to the Exchequer Office, there were two girls, a black and a brown, who escaped with only a few bruises about the ruins. We are informed of the following strange event that transpired in the house of Don Jose Maria Rodriquez: During the commotion of the earth a female child was asleep in its bed, beside one of the walls within the house, while its mother and a little girl were reposing at the other side in an adjoining chamber, and near to a third wall. Both walls fell, yet neither of the three received any injury.

Among the shipping, some individuals were playing at draughts, during the earthquake, some of whom threw themselves into the sea, so violent were the un-

The edifices attached to the estate called Ignoranda have all been destroyed; fortunately there were no persons in them at the time.

NOVA SCOTIA.

The responsibility, resources, and capacity of Messis. Sykes. Brookfield, and Kings, have been ascertained to be all that their best friends could wish.

An important clause in Mr. Jackson's pro-position, by which it appeared that in case the Bonds of the Province did not rise to 15 per cent the Government was to make up the difference has been struck out

So far, so well. But Mr Howe has not been content to leave his country at the mercy of any contractors, however highminded or adventurous. He has therefore brought with adventurous. He has therefore brought with him estimates from disinterested parties, backed by tenders from persons who will supply, at the prices named, every article that Nova Scotia would require to import to make 300 miles of Railroad. He has also completed an arrangement with one of the first houses in London, by which Nova Scotia can command a million sterling on her own credit, to do
the work, if she so decides, with cash in hand,
and without reference to who may be the Contractors.

The upshot of all this is, that the country is

now free to make either the Main Trunk Line by itself or the Main Line and both the branches. It can do its own work, on the strength of its own resources, even if no aid be given by the Imperial Government; and it has the near prospect of that aid, if the kindly disposition of the present Cabinet is rendered available, by wise and prudent conduct, for the elevation and advancement of British America.
