Gladstone, to explain and amend the Laws relating to the Church in the Colonies, is vague and general in its terms, and proposes to delegate indefinite powers to Colonial Church Synods, for the management, of their Ecclesiastical affairs, and such intended change in Colonial Church Government is attempted to be thrust upon us unasked for, by the Churchmen of this Province, for, by the Churchmen of this Province.-

Resolved, that in the opinion of this meeting this Bill emanating from such a source, is calculated to excite the well grounded suspicions and alarm of Churchmen in this Pro-vince; and should it unfortunately pass into a Law, such Synodical action will inevita-bly tend to aggrevate the difficulties and widen

the differences, now unhappily existing in the Protestant Episcopal Church. Moved by Henry W. Baldwin, Esq. seconded by Thomas H. Carman, Esq.

Resolved, That the toregoing Resoltions, signed by the Chairman and Secretary, be forwarded to the Lord Bishop of this Diocese, and to the Church Wilness, for publi-
