Two Hundred and Fifty Thousand Dollars
Lost.—The Hon. Alonzo Sabine, member of

To this add the expense to which the British government is subjected in sustaining that armed force, and some estimate may be formed of the disadvantage under which both nations labour in not entering into arrangements for mutual reci-procity.—Boston International Journal.
