pression to the manifest injustice done to Jurymen in this Province, and we doubt not the evil will soon be remeided. In the United States, we believe, each Juror receives 7s. 6d. a day, besides his travelling expenses; and we see no reason why in this Province, where our laws in general are so impartial and just, this state of things should be allowed to exist."

RUSSIA.

It appears by the following intelligence conveyed to the New York Commercial Advertiser. by their Correspondent in Paris, that Russia is already beginning to feel the loss of her trade :-

"The Russian paper currency has fallen to a discount of 12 per cent. and several failures have taken place at St Petersburgh and Riga, as well as in the interior. The finance question is likely in the end, to be to the Czar, in the present war, what the Winter at Moscow was to Napoleon in 1812. It will wear him out, because it is an elsment with which he is wholly unprepared to deal. In his own territory he is unassailable, but he cannot keep armies in a distant country without money."

P. E. ISLAND.

We have much satisfaction in transferring the annexed paragraph copied from Haszards Charlottetown Gazette, to our columns :

"We have been request d to state, that the Electric Telegraph will be in working order by the end of this week, or the beginning of the next, when the line will extend from Charlottetown to the United States, Nova Spotia and New Brunswick. A complete settlement of the affairs of the Company has been made, and the payment of its debt, liabilities, &c., are guaranteed by several of the wealthiest men in New York. Mr Hartly J. Gisborne has arrived in Charlottetown, and is busy forwarding a Bill through the local Legislature, similar in some respects to one passed in Newfoundland, for incorporating the Company, and giving it an exclusive right, for a particular period, upon the performance of certain conditions."

He had subsisted on the rotten wood in and about his den, for the 5 months. and had evidently taken a considerable exereise, for the snow for about 20 feet around was beaten quite hard."

The premises in question were built entirely of stone, and approached completion, having been commenced in 1851.—St. Oliver street, St. John Suburbs, was six floors high, and the wings and the contained four stories. on either side contained four stories.

The church and convent we are told were insured in the Royal (£3000) and Equitable (£3000) offices for £6000, which will not at all suffice to cover the loss suffered.
