The following Resolution was then moved in a brief address by the Rev. Mr Murray, and seconded by Henry W. Baldwin, Esq. Resolved, That the Bible Society, formerly in operation here, but of late years suffered to decline, be now revived and conducted hence-forth in accordance with the following forth in accordance with the following

RULES AND REGULATIONS. I. This Society shall be called "The Glou-cester County Bible Society, the object of which shall be to co-operate with the British and Foreign Bible Society, in promoting the dis-tribution of the Holy Scriptures without note or comment, and shall furnish copies of the Scriptures gratis to the indigent, and at reduced prie es to others.

II. In order to give effect to the design of this Institution, benefactions and subscriptions shall be solicited, and books opened to receive

the names of benefactors and subscribers. III. Every person contributing annually Five Shillings at one time, shall be considered a member of this Society, and a donation of Five Pounds shall constitute a member for life.

IV. The business of this Society shall be conducted by a President, three Vice Presidents, Treasurer, Secretary, Depository or Depositories, and not less than six other members IX. It shall be considered the duty of the Committee to ascertain what families or indi-viduals, residing within the sphere of their operations, are in want of Bibles and Testa-the Atlantic from Liverpool at 5 o'clock, ments and unable to procure them, in order to their being supplied, at prime cost, reduced prices, or gratis, as circumstances may require.

COUNTY RESTIGOUCHE.

EXTRACT of a letter from Dalhousie, dated May 15, 1856 :

" Your paper has chronicled a number of disastrous fires this short time past, the last you mentioned took place in Bathurst.

"The calamity appears epidemical, and is extending to the northward. Last week the dwelling house belonging to Mr Rufus Cham-berlain, Oak Point, on the Canada side of the river, was burned to the ground. On Tuesday last a fire broke out in a building in the upper part of this town. The house was occupied by three families, who all suffered loss to a considerable extent, but the principal sufferer is Mr Charles Gautier, who occupied the apartments nearest the top of the building, where the fire originated. In addition to the loss of his furniture, clothing, bedding, and a large quantity of household supplies, a sum of money exceeding £50, the fruit of his industry and economy, was consumed. The weather was dry, and the wind blowing freshly at the time, and the whole range of buildings on one side of the street was in iminent danger of being burned down. Three dwelling houses and a new store in the range had caught fire at one time. The accident occurred at the dinner hour, and a number of active persons were speedily on the spot, whose praiseworthy exertions, and a good supply of water, prevented much individual suffering, and a great loss of property. LOCAL.

FIRE AND ROBBERIES .- Just as our paper was put to press last week, we received from a friend in Douglastown, the following particulars of the Fire which had occurred at that place, and also an account of the Robbery of two Stores in that town the preceding night :--

"Our usually quiet little town has been thrown into a state of great excitement within the last few days by the fol-lowing occurrences. On the morning of Thursday last, the Barn of Mr Alexander Jessiman, was discovered to be on fire. The Barn and Outhouses with nearly all their contents, were totally destroyed. Mr Jessiman has been a severe sufferer; he has lost from Four to Five Hundred Pounds worth of Property. One part of the building was occupied by R. T. Millar, as a provision store, and Flour and Meal to the amount of Two Hundred Pounds were destroyed. Mir John Mc-Cosh, also lost to the amount of Twenty Pounds in Agricultural Implements. The origin of the Fire still remains unknown. There was no insurance on either Millar or Jessiman's

roperty. "On Friday last, the stores of Mr Charles Marshall and Mr Alex. Taylor, were broken into by some burglars, and cash to the amount of between £8 and £9 was taken from the desk of the former, and between £60 and £70 from the latter gentleman. No clue as yet to lead to the detection of the parties." Information having been lodged with the

authorities, casting suspicion on a man named Kenneth Bigger, a warrant was made out and placed in the nands of Messrs. McRae and Kelly who, having learnt that the accused party had left for Bathurst, proceeded at once in pursuit, and arrested him at a house about twelve miles from that place. Much credit is due to Messrs. McRae and Kelly for the interest they manifested in the matter, and for the prudent and skilful manner in which they performed their unpleasant and hazardous duty.

The prisoner was examined before John T Williston and William Letson, Esqrs., who committed him for further examination on Tuesday next. It is improper to state the various rumours that have been afloat respecting this man, but if he be the guilty party, we hope something will be elicited on Tuesday to bring the matter home to him.
