COUNTY RESTIGOUCHE.

A Correspondent writing to us from Dal-housie, under date of August 27, furnishes the following account of the opening of the Court by Judge Ritchie, and a copy of an Address presented to him by the Grand Inquest of the

Yesterday the Supreme Court was opened here under the presiding of His Honour Judge Ritchie, who is likely to have a busy week of it. There is, we understand, more than an average number of civil suits to be tried at this court; sevaral of them involving important principles of law—a fact which shows that the law is not at so low an ebb as your Correspondent's late remarks would seem to imply. On this occasion there is a considerable number of magistrates, grand and petit jurors, with other official and inter-ested parties When each had fallen into his ranks—when the various relations of plaintiff and defendant, of council and client, of the anxions and the indifferent were assuming for the time "a local habitation and a name when the grand jury, having chosen their foreman, had returned into court, the judge delivered his charge, in which he called attention to the important nature of the duties which, for the viridication of justice and for the protection of the public liberties, the constitution intrusts to the grand inquest of the County. -He congratulated them, and through them, the community, on the gratifying circum-stance that on this his first visit to Restigouche he had had the pleasure of being presented with a blank criminal calendar, and concluded by expressing a hope, that no business of a public, or so far as he yet knew, of a private nature requiring to be brought before them; he should be able before adjourning to relieve them from further attendance at a season when absence from their industrial avocations involves a sacrifice of no trifling magnitude. In the afternoon the Grand Jury presented an address to the Judge, and His Honour, in happy and appropriate terms, thanked them for their flattering expressions of respect to himself personaly, and again complimented them on their devotion to the duties of the public care.

THE ADDRESS. To His Honour Mr Justice Ritchie:

The Grand Inquest of the County of Resti-gouche are fully sensible of the important du-ties which, by the constitution of the Empire, devolve upon them, and to which your Honour in your charge so forcibly and eloquently admount duty to attend to the public welfare of the community.
