" and in which the chocks are wrought with a but at each end," thus rendering it imperative that in Ships of the 10 years grade and above, the chocks shall be wrought with a butt at each end, unless they are built with square heads and heels, dowel-

led.

Section 51.— The Survey prescribed in this Rule for "all Ships not built under Survey, whether in the United Kingdom or abroad, for which a character may be claimed," will in future be required to be held by a Surveyor, who is an exclusive officer of the Society. It is not intended, however, by this Regulation, that any additional expense should be incurred. that any additional expense should be incurred

by the Ship-owner.

Section 52 will stand thus:—"Ships buil under a substantial and efficient roof, kept in good repair, which shall project, &c.," the alteration being shown by the words printed in Italies.

Section 53.—Prescribing that Ships built in the United Kingdom or the Colonies, where there are resident Surveyors to the Society, which shall not have been surveyed hill building, as required by the Rules, "shall have one year deducted from the period which would otherwise have been assigned," has been altered, and in future Two Years will be deducted in such cases, instead of one, as heretofore.—(Section 35 has likewise been altered in accordance herewith.)
