

less crusade against the police is not distinctly explained. One reason given is the closing of the lager beer saloons on Sunday, and the using of unnecessary and unjustifiable force in doing so. Another account refers the excited feelings of the Germans to the machinations of Mayor Wood and the old police, who circulated the rumor among the lower classes that it was the design of the Metropolitan police to close all the lager beer shops and exclude the Germans from any participation in the rights of citizens. The killing of Muller is ascribed to wantonness on the part of the police; the Germans say he was not a rioter, but a peaceful citizen, and was inhumanly shot by the police. To some one, or perhaps all of these cases, may be ascribed the outbreak of the usually staid and peaceful Teutons.

CHINA.

The summary of the China Mail, (Hong Kong paper), of May 9, is as follows:—
“In Canton the utmost misery prevails, and rice is enormously dear. In the Canton river, a little of importance has recently occurred, beyond an attempt made by the Chinese to blow up the Acorn, about 4 o'clock on the morning of the 3rd of May, by means of a large iron tank filled with gunpowder, that exploded close to the sloop of war, off Hamilton Creek, and the concussion of which was felt on board the Encounter and Elk, two miles off—so strongly, indeed, that the crews of these vessels imagined that it had occurred close to them. The tank is supposed to have been the boiler of the unfortunate steamer Queen; and the mode in which the Chinese attempted to carry out their project of destroying the Acorn was most ingenious. They first made a rope, fast to one of the stakes at the barrier, then a man must have floated down with the tide a distance of 800 yards, and fastened it upon the ship's cable. To this rope the tank was attached by bamboo rings, to make it slide easily, and thus allow it to drop down with certainty upon the vessel; and another line was carried from the tank to the shore, worked by means of a pulley, so as to guide the tank in any direction required. Very fortunately, however, the distance had been slightly miscalculated, and the explosion took place some seven or eight yards only from her bows. A similar ‘infernal machine’ was detected lately close to the Hornet.”

EUROPE.

ENGLAND.—*Corn Exchange, Mark-Lane.*—July 3.—We have had a change in the weather since our last. On Saturday and up to the evening of Sunday the heat was intense, when with a change of wind, the temperature lowered considerably, and remains so up to the time of our writing. Some smart showers have fallen in the metropolis, especially on Wednesday; and many parts of the country have been similarly visited, which will greatly improve the crops. The reports of the wheat are, on the whole, satisfactory; and, with favorable weather, cutting will commence at the latter end of the present month. Harvest has already commenced in Southern Europe, and in Algeria and Egypt it promises to be most abundant.

The country markets have presented a quiet appearance this week, and prices in some places have given way 1s to 2s per qr. on wheat; while in nearly all, the tendency has certainly been in a downward direction. Farmers are now busy with their haymaking, yet the deliveries of wheat are greatly in excess of last week (upwards of 17,000 qrs.) the return made up to yesterday comprising 120,368 qrs., at an average of 61s 6d per qr.

The arrivals of all kind of grain, both English and foreign, have been very light this week. Fresh up to Mark-lane this morning the supply of home-grown wheat was very short, but equal to the inquiry, which was dull, at previous prices; and the same will apply to foreign.—The flour trade was inactive, and 48s for Norfolk was an extreme price. Not much done in barley or malt. Oats met with a steady sale; and fine corn, being very scarce, was again rather against the consumer. No change in pulse.

Money and Commerce.—City.—The adverse news from India, the extreme depression which prevails in Paris, and the very active demand existing for money, caused the British funds to be extremely heavy and declining during the first few days of the week. Since then there has been a partial recovery, and Consols close somewhat firmer, but not materially so, owing to the extremely over-bought state of the market. The fall in rents upon the Bourse is mainly attributable to the rumours current relative to a new loan. The result has been that a large amount of that class of stock has been forced upon the Bourse, partly on speculation, and partly by the public, who generally feel alarmed when there is anything like a continuous fall.

CANADA.

Riot at Montreal.—Montreal, July 13.—On Sunday some rioting occurred here, in consequence of the display of the Orange flag. Crowds of people assembled in the vicinity of the flag, and several shots were fired at it, and two or three Orangemen beaten severely.

July 14.—Douglas Brothers saw mills, at the Canal, were burnt last night. Loss \$30,000. There were some rioting at and previous to the fire, between Orangemen and Catholics, several parties being injured.

Capt. Rudolf of the steamer Montreal, was arrested at Quebec to-day, on a Coroner's warrant.

SECTION 46. Every butt in each outside plank to be fastened with two bolts, one of which may be in the adjoining timber and one to be through and clinched.

SECTION 38. In the inside and outside planking waterways, plank sheers, and flat deck of full poops and top-gallant forecastles, a reduction of one fourth from the thickness required by the Table B. for such planks in the range of the upper deck in ships with two decks, will be allowed; and in the siding and moulding of the top timbers and beams of full poops and top-gallant forecastles, a reduction of one fifth will be allowed.

In the inside and outside planking waterways, plank sheers, and flat deck of raised quarter decks, a reduction of one fifth from the thickness required by the table B. for such parts in the range of the upper deck in ships with two decks, will be allowed. Table B. will be altered in accordance with the above.
