Sir-In reading the Journals of the House of Assembly, I perceive that you have displayed a praiseworthy exertion in introducing a bill 're-lating to the Sick and Disabled Seamens' Fund,' lating to the Sick and Disabled Seamens' Fund,' equalizing the duties on ships entering all Ports in the Province. While I admire your activity in this respect in the Legislative Halls, I cannot but complain of the mode in which you, as one of the Commissioners of the Richibucto Sick and Disabled Seamens' Hospital, have managed or rather mismanaged the affairs of that valuable institution. Such a system of rechlets valuable institution. Such a system of reckless expenditure in these days of reform, will not be passed over in silence. At present (like our Telegraph Company,) the Commissioners have no laws or regulations for the management of the Hospital, and like the above named company. ny, the whole supervision rests in the hands of an oligarchy. The result is apparent—private quarrels and animosities are made the causes of disunion among the Commissioners, and the most obstinate, rules the institution as he pleases. Under the present system, there is no regular medical attendant for the Hospital, but each Commissioner is left to his own choice to select out of the medical men practising in the County, to attend to the patients, and at the end of the year his accounts when presented to the Commissioners are reduced or not as they think fit. Is it not an insult to any educated man's feelings, to reflect, when he is attending the patients in the Hospital, that the pittance he is to receive for his services is under the control of mea totally unacquainted with the value of the duty performed, and he is well or ill remunerated according to the time he keeps his patients on hand, and not according to the inportance of the case, or the attention he be-stows on it. Candour must compel you to ac-knowledge that this is unfortunately but too truthful a picture of the Hospital at Richibucto; and you must confess that the usefulness of this institution is retarded and rendered almost nugatory by the dead clogs of unaccountability, imberility, and want of union and method. -Having thus briefly pointed out some of the evils (I say some, for their name is legion;) existing under the present system of misrule and mismanagement, permit me to suggest for your special consideration the remedy and a

In the first place the Board of Commissioners as now constituted, do not possess the confidence of the County; follow the example of high auof the County; follow the example of high authority, and remove them at once; you must feel the incapacity of your colleagues, one from ill health being unable to do the duty as he otherwise would; the other a grumbler—reorganise then your board, and replace them with active energetic men. The public raight then hope that yourself with two efficient colleagues would do the work to their satisfaction. Second—let all the necessary contracts for repairing and maintaining the institution, and for the cure, care, (I follow the words of the act) "attendance and support of the patients therein," be let out to the lowest tenders, under certain regulations, either yearly or for under certain regulations, either yearly or for such time as a majority of the board should deem most conducive to the interests of the in-

Third - work together in unanimity and good will, always remembering that the people (your masters) hold you responsible and accountable to them for your actions.

Lastly-I close these remarks with confidence believing that it is your earnest wish to serve the public honestly and faithfully-should however your actions and conduct hereafter compel me to change my present opinion, rest assured that you will hear of the same from the pen of your obedient servant,

LEGISLATIVE PROCEEDINGS.

THE Telegraph reports, and the extracts from the Journa's, which we publish in another page, will enable our readers to form a correct id a of what is DOING in our Legislature; for the SAYINGS we refer them to the Debates, which are published under the auspices of the Legislature, and to the St. John papers, the proprietors of most of which have Reporters or Correspondents in Fredericton. The extreme length of these Debates precludes the possibility of our giving a synopsis of them, and it appears the Reporters, as well as the Publisher who undertook to print them, find it an Herculean task, for they are sadly behind. This will ever be the case while the present system is pursued of every member striving to speak as long as he possibly can on every subject of moment that may be brought under the consideration of the House.

The most important question, in our opinion, which has yet passed the Assembly, is Mr.Gilbert's Bill, Disqualifying all persons holding Offices under the Government, from sitting as Members in the Assembly. We have not seen the Bill, but we presume the Officers alluded to are Clerks of the Peace, Deputy Treasurers, in fact all Offices to which there is attached a Salary, and the incumbent can be removed at any time therefrom by the existing Government. This will unseat a good many of the present. members. We were astonished to find that it passed with so little opposition. From this circumstance we are inclined to augur that it will not become law. The members knew it was a very popular measure, and that it would be dangerous to oppose it; they therefore trust the Council will give it the go-by, that they will throw it out. This is a dodge frequently resorted to by the House; we believe it was so with the Prohibitory Liquor Bill. The House passed it but were in hopes the Council would ignore it, and take all the censure. In this they were deceived, and we trust the Council will adopt the same course in reference to this disqualification bill.

The Speaker made an effort to carry an amendment-that the members of the Government, or all Heads of Departments. Bankers, &c., be excluded from holding seats in the Legislature. This, so far as the Heads of Departments are concerned, is, in our opinion, impossible under the present system. It is a prominent feature in the Responsible Government
