Public Notice.

WHEREAS the CORPORATI-
ON of the City purpose Build-
ing a BRIDGE on the Public High-
way, leading out of the City, towards
the INDIAN-HOUSE, to commence at
the City side of the Saw Mill, down
thence to run in a direct line to *Whoo-*
ten's Point, so called, agreeable to the
following out lines, to wit—At the end
nearest the City, a Butment composed
of Logs (not less than 12 inches diam-
eter) in the form of a Wharf, and suffi-
ciently ballasted with stone, 12 feet by
25, from which five large strong pieces
(not less than 14 inches diameter) to be
extended, to reach the Rocks at *Whoo-*
ten's Point, thence to be supported under
in three different places by good and
sufficient Posts and Girds, the whole
to be laid over with a Flooring of Cedar
Logs, not less than 8 inches at the
small end, and to be well covered and
made smooth with gravel. The Bridge
to be 25 feet broad, and 120 feet long,
and guarded on each side with staunch
hand Rails four feet high. The par-
ticular plan may be seen at the Office
of the Common Clerk, to whom all per-
sons wishing to Contract for the build-
ing of the above Bridge, will send in
their Proposals in Writing, (Sealed) on
or before the 10th day of FEBRUARY
next.

A PROCLAMATION.

BY Virtue of the Power and Au-
thority granted to me, in and by
an Act of Parliament made and passed in
the Twenty-eighth year of His MAJES-
TY'S Reign, intituled, "An Act for re-
gulating the Trade between the Subjects
of His MAJESTY'S Colonies and Plan-
tations in North-America and in the
West-India Islands and the Countries
belonging to the United States of Ame-
rica, and between His MAJESTY'S said
Subjects and the Foreign Islands in the
West-Indies"—I do, by and with the
advice and consent of His MAJESTY'S
Council, publish this Proclamation,
hereby authorizing and permitting
Wheat, Rye, Rice or Indian Corn and
the Flour of Wheat or Rye—also Ash
Oar-Rafters and Capstain Bars, Staves,
Heading and Treennails, to be imported
by British Subjects in British built ships
owned by His MAJESTY'S Subjects
and navigated according to Law, from
any of the Territories belonging to the
United States of America, for and dur-
ing the term of Six Months from this
date—and of this Proclamation all Per-
sons whom it may concern will take due
notice and govern themselves accord-
ingly.

dred and two, and in the forty-
second year of His MAJESTY'S
Reign.

The Town and Township of DIGBY.

AS It is probable that the Peace
which has lately taken place, may
occasion many military and other tran-
sient persons to look for settlements in
these Provinces, and as some such may
incline towards Digby (where a field
offers itself suited to various kinds of
adventurers) several gentlemen of that
place have associated for the purpose of
removing (as much as is practicable)
such difficulties as are most likely to op-
pose themselves to new settlers—

To prevent imposition, uncertainty
and delay from discouraging new co-
mers, they have selected and secured
a number of commodious house-lots in
the Town-plot, upon each of which,
they have fixed a moderate price, not
exceeding the lowest rate of selling for
three years past—a proportion of these,
adjoining the water, are adapted to tra-
ding persons.—Others, are calculated
for mechanics—and a few more, for
such as are only concerned in having an
agreeable building spot for a house, and
room for a garden. The first applicant

The Township of Digby extends from
the Gut of Annapolis westward to its
extremity of the Province of Nova-Sco-
tia, and contains about one hundred and
fifty thousand acres; of which, a body
of about twenty five or thirty thousand,
lying to the southern or inland side, is
still in the possession of the crown, un-
granted; the remainder is all appropri-
ated, surveyed, divided into lots and
planned—and, by the care of Govern-
ment, it has lately been secured to the
present owners under a clear and effect-
ual grant. The lands in general are
food, well wooded and watered; and
the Township throughout its whole
length is interspersed with settlements
—Being washed by the Bay of Fundy
and deeply indented by St. Mary's Bay,
it has a great proportion of sea coast, and
an ample share of all the kinds of sea-
fisheries common in Nova-Scotia.

The Town-plot is situated at the East
end of the Township, just within the
entrance of the Annapolis Basin, and

twenty miles, to where, it terminates
with the Fort and Rivers-mouth of the
name. It was settled by Loyalists from
New-York in the year 1773, the most
of whom went early to farms, or moving
to older countries, left the whole side to
be bought up and improved by about
sixty families, who now reside in it, ha-
ving detached but comfortable dwell-
ings, with little gardens and orchard
and carrying on some fishery and fi-
reign trade. It has good communica-
tion both by land and water with
parts of the County of Annapolis. Pro-
visions in it are plenty and cheap.
Building materials readily to be pro-
red, and from many local circumsta-
ces, there is a probability of its becom-
ing a place of some consideration for
ship-building, the fisheries and west-
India Trade, as well as a pleasant, cheap
and comfortable place of residence.
