His HONOR the PRESIDENT having yesterday Inform- ed His MAJESTY'S Council, that he had received a let- ter from Sir GEORGE PREVOST, requiring him to hasten to Halifax to assume the command of that District, and that, on his arrival there, arrangements were to be made respecting General BALFOUR'S removal to this Province; the Council this day presented to His HONOR the following Address.

To the Honorable Major-General HUNTER, President and Commander in Chief, &c. &c. &c.

The humble Address of His MAJESTY'S Council of the Province of New-Brunswick.

SIR,

When His MAJESTY, three years ago, was pleased to appoint your HONOR to be our President, it was a sub- ject of joyful gratulation throughout the Province: for the Civil Administration was then committed, by His MAJESTY'S express nomination, to one who, in his Mi- litary command, had already merited the grateful ac- knowledgments of a loyal People, expressed by the unanimous voice of their Representatives in General Assembly. Nor on this nomination have we experi- enced the smallest variance of sentiment. The confi- dent anticipation, with which we then relied on your zeal for the honor of His MAJESTY'S Service and for the safety and prosperity of this Province, has been most completely justified; and we have long indulged the hope that, since the return of General CARLETON was no more to be expected, some adequate mark of His MAJESTY'S favor to him might ere now have pre- pared the way for appointing you to be his Successor in this Government.

It is therefore with deep regret and concern that we have received the information of your immediate remo- val, especially at a time when so much may possibly be hazarded by any diminution of that zeal and confi- dence with which you have inspired our Provincial Militia. And we trust it will not be thought improper for His MAJESTY'S Council, on this occasion, to express a hope, that some arrangement may speedily be made to secure the Province from the mischiefs of an unset- tled and precarious Government. To our situation, in this respect, we request you to solicit the favorable at- tention of His MAJESTY'S Ministers.

While we lament our own loss, we sincerely hope that, to yourself, this removal may prove a prosperous event; and in this hope we request you to accept the warmest assurances of our unfeigned esteem and affec- tionate regard. When you leave this Province, the best wishes of every heart will attend you.

To this Address His HONOR was pleased to return the following Answer.

GENTLEMEN,

For this very kind and obliging Address, I beg you to accept of my sincerest thanks. It has been my ar- dent ambition to fulfil the duties of the station which I have held in this Province; but I am fully sensible how much I am indebted to your zealous aid and dis- interested advice for whatever success may have attend- ed my administration. This testimony, so well merit- ed, I shall, on all proper occasions, be happy to make in behalf of His MAJESTY'S Council of New-Brunswick; nor shall I neglect any fair opportunity of soliciting the favorable attention of His MAJESTY'S Ministers to the future prosperity of a Colony so dutiful and loyal.

To the Honorable MARTIN HUNTER, Esquire, Major- General, Commanding His MAJESTY'S Forces in the Province of New-Brunswick, and President of the same.

A number of the Magistrates and principal inhabit- ants of the County of York, beg leave to approach your HONOR with an Address, which would have been rendered more Official, had not your sudden departure prevented; fully persuaded that in expressions of re- spect and esteem for your HONOR, we speak not only the language of our absent brethren, but of every re- spectable Member of the community.

In times of peculiar interest and anxiety, we have reflected with much confidence and satisfaction, that we were under the immediate command of an Officer of distinguished Military talents, and established zeal for His MAJESTY'S Service; and we trust that thus commanded in case of emergency the Militia of this Province would have given unequivocal proofs of that Loyalty which is their pride and characteristic.

In the administration of the Civil Government, we have witnessed instances of your exertions upon all oc- casions where the interest of the Province required them; we have also seen the salutary effects of those honorable and steady principles which have influen- ced the public conduct of your HONOR.

Under these impressions we feel it a duty which we owe to this society, to express in the warmest language of affection and respect, our sincere regret at your de- parture; while at the same time we cherish the hope that this removal may terminate essentially to your ad- vantage, by placing you in a situation more extensive and useful.

Other sentiments press upon our minds when we contemplate the examples which you have offered to our view in private life, where you have blended a li- beral and cheerful hospitality, with a rigid and careful performance of every christian duty; nor can we close this Address to your HONOR without indulging an ex- pression of admiration, while we take a retrospective view of the many and delicate instances of benevolence and kindness which have flowed from the bountiful hand of the pious and amiable Mrs. HUNTER, whose general complacency and goodness have secured her the esteem of the whole community; we can only add

our best wishes for the health of yourself and family, and that every blessing may attend you.

GENTLEMEN,

I sincerely thank you for the expressions of esteem and regard contained in this Address, and in particu- lar for the tribute of respect which you have paid to Mrs. HUNTER.

During my residence here I have witnessed many proofs of that dutiful attachment to His MAJESTY, and zeal for his service, by which the inhabitants of the Province in general have been so long distinguished.— The Militia in this, and in every County, have appear- ed ambitious to merit my approbation and confidence; and at this critical time it would have been my wish to remain in a situation where upon emergency, I doubt not I should have found them every way worthy of the expectation I had formed of their future conduct.

The time which I have spent among you, Gentlemen, will always be remembered by me with pleasure, and I shall at all times be happy if I can in any way contri- bute to the welfare and prosperity of this Province.

To His Honor Major-General MARTIN HUNTER, Pre- sident of His MAJESTY'S Council, and Commander in Chief of the Province of New-Brunswick, &c. &c.

WE, His MAJESTY'S faithful and loyal Subjects, the Mayor, Aldermen and Commonalty of the City of Saint John, assembled in Common Council, beg leave to approach your HONOR with sentiments of the high- est respect, and most perfect esteem.

If we may be permitted to express our opinion relating to public measures, we assure you, Sir, that we are fully persuaded the Province at large will ever feel greatly indebted to your HONOR, for the benefits derived from your very able, just and impartial admi- nistration of the Government; and we are confident your HONOR will carry with you, the most sincere re- spect and esteem of all its inhabitants, without a single exception.
