The divine Author of our religion no sooner entered upon his public ministry, than he began to prepare for the establishment of his Church. He chose from among those who followed him twelve disciples, and after them seventy others of an inferior order, whom he sent to preach in his name. And before he left the world, that no sanction of authority might be wanting to those who were to administer the affairs of his Church, that they might appear as ambassadors in his name, furnished with full and clear credentials, he appointed the eleven Apostles to meet him on the mountain, which had been the scene of his former humiliation and agony, and was now to become the theatre of his glory.—And there, when he was just about to enter into his rest, he gave them a solemn and formal commission, founded on the authority which he had received from his Father, "All power is given unto me in heaven and in earth. Go ye, therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost; teaching them to observe all things whatsoever I have commanded you: and, lo, I am with you alway, even unto the end of the world."† The first public act which is recorded of these Apostles after their Lord's ascension, was to preserve the integrity of that high order to which Christ had appointed them, (Acts i. 15, 16.) And as he delivered an outward commission to his disciples, so we find them proceeding in the same method. As the Church increased in numbers and extent, or, as their fellow labourers were removed by persecution and death, they ordained others in the various orders of the ministry; and invested them with the power, which they had themselves received immediately from Christ himself, to preach his word, administer his sacraments, perform the services of religion, and each in their several offices, to maintain "the unity of the faith in the bond of peace."‡ Into this Church, or society under the government of the Apostles, all who were converted by their preaching were baptized: all were required to pay obedience to its institutions, and hold communion in its prayers and ordinances; "they continued steadfastly in the Apostles' doctrine and fellowship, and in breaking of bread, and in prayers; and the Lord added to the Church daily such as should be saved."§ Here then I trace the establishment of an outward and visible Church: I mark the care and earnestness of our heavenly Master to institute a ministry charged with all the powers and authority of a divine commission; I observe the attention of the Apostles to keep up the orders and institutions of the Church, and to perpetuate them to the end of time: and I cannot after this believe it a matter of indifference, whether I belong to any Church, or whether I belong to a false Church or to the true.

RESOLUTIONS OF SUPPLY.

To the Honourable Anthony Lockwood, the Surveyor General of the Province, the sum of £50, to defray the expense of office rent, for the years 1820 and 1821.

To Messrs. E. Barlow, & Sons, the sum of £221 2, being the amount of debt on rum, exported on board the Sloop, Newcastle, which vessel was lost, consequently the requisite certificate of exportation cannot be obtained.

To Thomas H. Pent, Esq. Dep. Treasurer at Miramichi, the sum of £53 2, paid by him into the Province Treasury, but which he had omitted to charge.

To Jas. McLean, the sum of £75 2 8, amount of drawback on rum and sugar, exported by him to Boston.

To Toler Thompson, the sum of £41 4, the same being the balance due to him of the grant of £100 granted in the year 1817, for cutting a Canal from Mud Creek to the nearest Lake at the head of the great marsh in Sackville, and which said balance the Supervisor was unable to pay for want of funds.

Thursday, 14th March.

To John Wilson, the sum of £37 10, being the amount of drawback on 10 puns.

Rum exported by him to Nova-Scotia, in 1818.

To Feiron Sealby, & Co. the sum of £36 3 6, paid by them to the Dep. Treasurer at Miramichi, under the Law imposing a duty upon non-residents.

To Eleanor O'Neal, the sum of £20, in addition to the grant of last year, to remunerate her for the expenses incurred by her late husband Daniel O'Neil, in maintaining Thomas Loudy and his wife, two aged and infirm Paupers, at Mace's Bay, for 2 years, previous to the County Line being established between St. John and Charlotte.

To Thomas Millidge, Esq. the sum of £51 12 3, for interest paid by him as bond as Surety for Robert James.

To Charles Smith, the sum of £30, to assist him in keeping a house for the accommodation of travellers, on the Portage between Nashwalk and Miramichi Rivers.

Whereas the populous and extensive County of Northumberland, hath but in one instance participated in the grants made by His Majesty's Government, and by the Legislature of this Province, for the erection of Churches: And whereas a number of the Inhabitants of Saint Peters, in the Parish of Saumarez, (who reside at the distance of upwards of 45 miles from any Protestant place of worship) have subscribed largely for the erection of a Church in that Parish—Therefore resolved, that in aid of those exertions of the Inhabitants of that Parish, the sum of £100 be granted to His Excellency the Lieutenant Governor, to be applied towards the building of a Church in that Parish.

Whereas the sum of £100, granted at the last Session, for defraying the expenses of Counsel to be employed before Parliament on the subject of the Timber duties, was not required for that purpose—Resolved, that the same be re-appropriated and applied to the payment of any expense, that may have been incurred by the Committee of Correspondence on that subject.

To three such Commissioners as His Excellency the Lieutenant Governor may appoint, the sum of £150, for the support of a Packet to ply between Digby and Saint John, for one year, to commence from the 5th day of April next—provided no Packet is established at the exclusive expense of the General Post Office, for that purpose.

To Commissioners to be appointed by His Excellency the Lieutenant Governor or Commander in Chief, the sum of £500, to be by them expended towards enlarging and improving the Province Hall, by erecting an office for the Surveyor General, a Committee Room for the House of Assembly, to be joined to the main building on the North-western end, and towards connecting the Secretary's office with the Province Hall, and to provide a Room for the accommodation of the Judges of the Supreme Court, and an office for the Clerk of the said Court.

To His Excellency the Lieutenant Governor and Commander in Chief, the sum of £100, for the support of the Master of the Grammar School in the County of Northumberland, agreeably to the Act of the General Assembly.

To His Excellency the Lieutenant Governor and Commander in Chief, the sum of £100, to be by him expended in support of the Master of the Grammar School in the County of Westmorland, agreeably to the Act of the General Assembly.

Friday, 15th March.

To the Commissioners to be appointed by His Excellency the Lieutenant Governor, the sum of £500, towards building a Marine Hospital and Pest House, in the City and Port of St. John.

To the Justices of the Peace for the County of Westmorland, the sum of £150, towards completing a Court-House and Gaol in that County.

To the Justices of the Peace for the County of Sunbury, the sum of £200,
