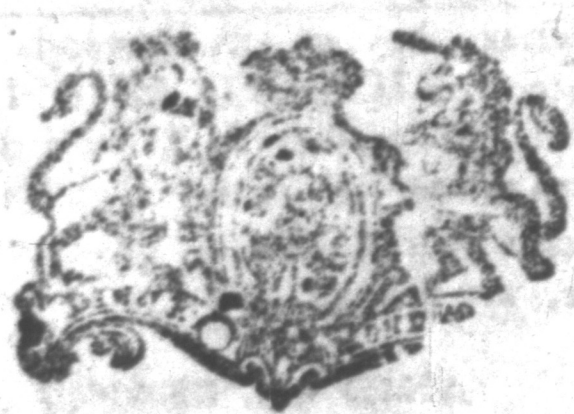

The Duke of Angouleme reviewed the troops assembled on the plain at Perpignan, about 10 o'clock. They were composed of two battalions of the 7th regiment of the line, two of the 18th, two of the 26th, one of the 32d, one of the 60th, and another of the 6th, of the 18th, and 23d mounted chassours, to which are joined the two squadrons newly arrived from Carcassone, of 250 foot and 60 horse artillery, with 50 soldiers of the train.

The Quotidienne says that hostilities will not commence till the 10th inst. The statement that the French army would cross the Pyrenees on the 1st seems to have been unfounded.

His Honor the President arrived here from St. John on Friday evening last, and returned again this morning.
