A PROCLAMATION.

IN Pursuance of the Powers vested in me by an Act of Parliament passed in the Sixth Year of the Reign of His present Majesty intituled "An Act to regulate the Trade of the British Possessions abroad," I have thought fit, by and with the advice and consent of His Majesty's Council, to appoint and I do hereby, by and with the advice and consent aforesaid, appoint the Town of Fredericton and the Parish of Woodstock in the County of York, as Places of

entry of Goods brought or imported from any adjoining Foreign Country pursuant to the Provisions of the said Act. Of which all Persons concerned will take due notice and govern themselves accordingly.

Given under my Hand and Seal at Fredericton, the first day of March in the year of our Lord one thousand eight hundred and twenty-six and in the Seventh year of His Majesty's Reign.

FIRE AT MIRAMICHI, AND OTHER PLACES IN THE BRITISH COLONY OF NEW-BRUNSWICK.

London Tavern, Nov. 11, 1825.

At a meeting held this day, pursuant to public advertisement, to take into consideration the most effectual means of affording early relief to the sufferers in the above calamity:

Resolved.—That it appears to this meeting that most extensive and destructive Fires have recently occurred in the Province of New-Brunswick, at Fredericton, and particularly on the North Bank of the River Miramichi, where a large tract of Country has been laid desolate; the town of Newcastle, Douglastown and the other settlements in that District, almost totally destroyed, with an afflicting loss of human life, and the surviving inhabitants, amounting to several thousands, left at the commencement of winter, in an inclement region, destitute of shelter, clothing and sustenance, with which it is not possible for them to be wholly supplied by the unassisted exertions of the neighboring Settlements.

That to afford relief to those who, by this unlooked for event, have been maimed or mutilated, and to the numerous individuals and families who have been suddenly reduced from comparative comfort to houseless beggary, a Subscription be immediately opened.
