PROVINCIAL CATTLE SHOW.

Pursuant to a Resolution of the New-Brunswick Agricultural and Emigrant Society, a Cattle Show was held on the 9th instant, at the Race Course, in this Town. The day was unfavourable, yet the Exhibition was numerous and respectably attended. It was honored with the presence of His Excellency Sir HOWARD DOUGLAS, who came from St. John, for the purpose of attending on this interesting occasion, and expressed himself highly gratified with the scene.

The decision of the Judges of Horses is as follows:—

"We the Subscribers having been requested to judge and decide on the superiority of the different descriptions of Horses produced at the Cattle Show at Fredericton on the 9th day of October, 1827, for the purpose of obtaining the different Prizes offered by the New-Brunswick Agricultural and Emigrant Society, at their General Meeting held at the Province Hall on the 7th day of March, 1827, are of opinion, that the Hon. George Shore's Provincial bred bay Stallion, 4 years old, is the finest Horse shown, for general purposes, and entitled to the first prize of £100 0 0.

"We are of opinion that of those produced from one to four years old, being Provincial bred, Mr. Crispy's 3 years old Horse Colt, is the finest shown, for general purposes, and entitled to the second prize of £8 0 0.

"We also decide that the Hon. Thomas Baillie's Provincial bred Mares, 5 years old, are entitled to the prize of £10 0 0.

"We think it proper to say that two remarkably fine Horses were shown, of the peculiar breed called Dray Horses, of which we consider Mr. Vail's 3 year old grey Colt, bred in King's County, (being stock from the noted Horse Goliath, imported by the Hon. John Coffin) the superior.

It being doubtful whether Mr. Baillie's Mares would, by the spirit of the Society's Rules, (from the circumstance of their not having been driven or used together as a pair,) be entitled to the Premium awarded by the Judges; it was resolved by the General Board that the question be referred to the decision of the Society at its next General Meeting.

By the decision of Capt. James Miles, Mr. Christopher Murray, and Mr. Moses Pickard, Judges of Neat Cattle, and other Farming Stock, the premium for the best Bull is awarded to Thomas Gilbert, Esq. of Queen's County. The premium for the second best Bull, to John Robinson, jun. Esq. of Douglas. Do. for the best bull Calf, to Col. Miles of Maugerville. Do. for the best Cow, to Col. Allen, of Kingsclear. Do. for the second best Cow, to Mr. L. R. Coombs, of Kingsclear. Do. for the best Ram, to Col. Allen.

Do. for the best Sow, to Mr. Jas. Biggs, of Fredericton. Do. for the best fat Ox, to Mr. Oliver Cougle, of King's County. Do. for the second best do. to Col. Allen. Do. for the best pair of working Oxen, to Col. Allen. Do. for the second best do. to William Camber, of Kingsclear.

The Show, both as regards the number and excellence of the Animals exhibited, far exceeded the expectations which the public had formed. The Horses of the Draught breed exhibited by Mr. Vail of King's, and by Mr. Hewlett of Queen's County, were much admired, as was also the fine two year old Colt belonging to Mr. Conliffe of Woodstock: but none of the stock appeared more to attract the attention of the Spectators than the beautiful bull Calves, belonging to Messrs. Hammond of Kingsclear. These were from the imported Short Horn Durham bull Hanover, purchased by the Society from Hugh Munro, Esq. of Bathurst, and afterwards sold to Mr. Archelaus Hammond. Col. Miles' Calf was rather larger than either of these, but for beauty and valuable points they cannot probably be surpassed in these Colonies.

Several superior animals were exhibited but not entered for competition; of these, the Bull, Heifer, Ram, Ewes and Lamb, Boar and Sow, belonging to His Excellency Sir H. DOUGLAS, were considered admirable specimens of their kinds, as were also the two Ayrshire Cows owned by the Secretary of the Central Society.

The striking improvement in some species of the Stock, and the interest which the public appeared to take in the exhibition, give assurance that our future Cattle Shows will be still more interesting and highly promotive of the Agricultural interests of the Province.

We invite the attention of our readers to the Sale of the imported Short Horn Durham Cattle, and Dishley Sheep, which is to take place at St. John, on the 25th inst. Several gentlemen by whom they have been seen, speak of them in the highest terms. From the superior size, and points of the fine bull Calves of the same breed, exhibited at the late Cattle Show—the one owned by Major Simon Hammond, and the other by Mr. Archelaus Hammond, it would appear that this race of Cattle, held in so high estimation in the Mother Country and in the United States, will prove a most valuable acquisition to this Province: and we cannot but hope that the new importation will be purchased by individuals in the several Counties, in order that judicious exertions of the Central Society may prove as extensively useful as possible.

If it should be imagined that the price of one or a pair of these animals, may be higher than one Farmer might find it convenient to pay; several in the same neighbourhood may unite in the purchase, and by so doing, the portion of money to be raised by each, would, comparatively speaking, be trifling.

It is not very probable (and we believe not expected by the Society) that the sales of these Cattle will cover the amount of costs and charges; but let them sell for what they may, one grand object which His Excellency Sir HOWARD DOUGLAS, and the Society have all along had in view will be accomplished, namely, the gradual improvement of our Domestic Animals by the introduction of Stock of approved excellence, from the Mother Country.
