

**York Agricultural and Emigrant Society.**

A Quarterly Meeting of the York Agricultural and Emigrant Society, holden at the County Court House, on Tuesday the 9th day of April, 1827— It was Resolved, that a Cattle Show and Ploughing Match be held at Woodstock on Friday the 7th day of September next, and Premiums as follow be given to the Owners of Animals that may then be exhibited.

- For the best Stallion, raised and owned in the County of York, not less than 3 years old, £5.
- For the second best do. do. £2 10s.
- For the best Bull, do. do. not less than 2 nor more than 4 years old, £3.
- For the second best do. do. £2.
- For the best Cow, not less than 3 nor more than 6 years old, do. do. £2 10s.
- For the second best do. do. £1 5s.
- For the best Ram, not exceeding 4 years old do. do. £2.
- For the second best do. do. £1.

And that Premiums as follow be given:—

- To the best Ploughman, £4 0 0
- To the second best do. 2 10 0
- To the third best do. 1 0 0
- For the greatest quantity of the best quality of Timothy Seed raised in the County of York, by any one Person, not less than 5 bushels, £3.
- For the greatest quantity of do. do. raised do. do. on one fourth of an acre, £2
- For the greatest quantity of Red Clover Seed, raised do. do. on one undivided acre, £3.
- For the greatest quantity of White Clover, do. do. do. £3.
- For the greatest quantity of the best quality of Wheat, raised on one undivided acre, £4.
- For the greatest quantity of Indian Corn, do. do. £3.
- For the greatest quantity Barley do. do. £2 10s.
- For the greatest quantity of Lapland Turnips raised on one undivided 1/4 acre of old land, do. do. £2 10.
- For the greatest quantity Flat Turnips, do. do. £2.

**The Sixpenny Wheaten Loaf to weigh 2lb. 5oz.**

And other Loaves in proportion. AND further Ordered, that each Baker do plainly mark the Initials of his Name on every Loaf of Bread, to be baked by him, together with the figures 6, or 12, (as the case may be,) to denote the price in pence, under a penalty of Ten Shillings for each and every offence.
