

Colonies, and not disposed to barter the solid advantages which they, in common with ourselves, should enjoy, for the plausible but empty pretext of reciprocal trade, held out by our American Neighbours.

GLASGOW, Aug. 23.

All the accounts received from the British North American Provinces, agree in stating the great advantages which these Provinces are deriving, and about to derive still further, from the trade with our Tropical Colonies being taken out of the hands of the United States and thrown into theirs. That this measure, lately resorted to and enforced by Government, will benefit all the interests and add to the prosperity and to the wealth of these valuable Provinces, cannot admit of a doubt, and which wealth and prosperity will quickly and greatly appear in the increased intercourse betwixt these possessions and the Parent State. No part of the latter will be more benefited by this increased intercourse than the ports in the Clyde. Instead of the shipping in these ports remaining idle for months each year, or following speculative unproductive voyages, the ill-employed portion will be actively engaged in the trade with these possessions and through them to our Tropical possessions; the freights increasing as those N. American Colonies increase in population and wealth. Several millions each year taken out of the hands of the U. States will thus be thrown into the latter. We are delighted to observe in the West India papers, received by last packet, the numerous arrivals in the different Colonies of British ships, with cargoes from the North American Colonies, instead of the arrivals being as formerly, American ships with cargoes from the United States. Our Free Traders not only never contemplated a trade so valuable and important as that which we mention, but their theoretical writers were all employed to write down the whole of these Colonial Possessions, and to represent them as useless and burdensome to the country. These days, however, are gone... vanished with the decay and the decline of that "cant and hypocrisy" which the *Morning Chronicle*, as we have elsewhere stated, tell us, are on the wane, or as we may add, consuming under the operation of the Sierra Leone fever, from which none recovers, and from which nothing that comes within its reach ever escapes.—*Glas. Pap.*

We are induced once more briefly to notice the subject of the TEA WHEAT, in consequence of having been politely favored with a sample of that grain and a few ears on the stalk, brought from the Parish of Mageriville. This fine Wheat appears to grow nearly the height of 5 feet from the ground, while that of the ordinary wheat we understand seldom exceeds three. The stalk is very stout, clear, and strong; the grain, a light transparent brown, large and full; and it is well worthy of remark that while all the common wheat, in the midst of which this sample grew, was completely lost to the Farmers, being ruined by the rust, the whole of this fine grain remained in the most sound and healthy state. We have only to reiterate our hope, that not a grain if possible of this year's crops of the TEA WHEAT will be suffered to go to Mill.
