AGRICULTURAL AND EMIGRANT SOCIETY. - In the Gazette of the 11th inst. we gave a brief outline of a benevolent design set on foot in Halifax, (N.S.) for the purpose of providing employment for the destitute people of colour in that vicinity, and thus, in the most effectual manner, to relieve their wants, by enabling them by their own industry, to support themselves. At the same time we made a suggestion, and expressed a wish that something of the same nature might be adopted in this place, for the relief of indigent people of colour, in this city, and at Loch-Lomond.

At that time, we were not aware of the measures which had previously been taken by the Agricultural and Emigrant Society, to improve the circumstances of those indigent persons. And we are happy to have it in our power, from respectable authority, now to state the following facts, relative to this subject. Early in the season, the Committee of the Agricultural and Emigrant Society, went to the Black Settlement, near Loch-Lomond, and called on, and took a particular view of every family and individual, noting their wants, and especially in the article of seeds for their lands for the present season. These wants after having been ascertained, were supplied, to the full extent of their capability of using seeds, and twenty pounds worth of the seeds bought by the Society this spring, has been distributed among them, under the particular inspection and superintendance of the Committee. In addition to this, judicious and well adapted means were used, to excite and quicken a spirit of industry, good management, and cleanliness among them. All which, will, we hope, produce a good effect. We know that in former years, in consequence of not being able to procure seeds, their lands have been nearly useless, and in the fall of the year they were destitute. Being therefore this spring supplied with seeds, and the season being very favorable for bringing forth the fruits of the earth, in an abundant measure, there is every reason to expect, that they will not be in the same state of destitution next winter. And having thus got a start, they will be able to succeed better, from year to year.

We have also to state, that through the indefatigable zeal of the Committee, to ameliorate and improve the condition of those Emigrants who may be sick upon their arrival here, a commodious house on the Marsh Road, well adapted for the purpose, about a mile from the public landing, has been taken for an Hospital. It has now fourteen inmates, [patients] labouring under fever and other disorders. The regulations adopted for their government and management, are, by what we have learnt, very judicious, and will conduce greatly to their comfort while sick, to their speedy recovery, and to their future industry and general good conduct. This measure has arisen out of the crowded state of the Alms House,
