LATEST INTELLIGENCE.

LONDON, Oct. 6.

The Lisbon Gazette of the 22d Sept. has an official announcement of the expected arrival of DON MIGUEL to assume the Regency; and the Gazette of the 24th, an advertisement for contracts for the supply of the British Army with provisions for six months from the 21st instant. It is therefore evident that the return of DON MIGUEL will not necessarily relieve our army from its present service.

LIVERPOOL, Oct. 11.

The Hon. Albert Gallatin, Ambassador from the United States to this country, embarked on Monday in the packet ship Sylvanus Jenkins, with his family, for New York. His Excellency left his charge d'affaires in London: and we apprehend, from the advanced years of Mr. Gallatin, that we shall not see that able diplomatist again in this country. We believe he has not succeeded in the main object for which he last came over to England, namely, to negotiate with our government on the intercourse between the United States and the British West Indies; and we suspect that the late Mr. Canning convinced Mr. Gallatin himself of the unfair conduct which has been pursued by the United States, in respect of British ships.

It is publicly and generally stated at the west end of the town this afternoon, that the nature of the despatches received in Downing-street yesterday, has led Government to come to the decision of ordering the fleet in the Mediterranean, to prepare for the general blockade of the Dardanelles. It was added that orders to this effect were to be sent out immediately, and in some quarters it was said, that they had been already transmitted but this we find on inquiry not to be the case.

Private letters from Constantinople state that the Sultan has consented to negotiate, on the understanding that Greece would be the only topic in which the Allied Powers were determined to interfere.

OCTOBER 13.

The latest accounts of the operations of the Greek forces are (if we trust them) calculated to inspire much confidence. Their arms are said to have been triumphant in more than one encounter, much has been effected by Church and Cochrane, to reconcile the chiefs, and to restore subordination.

MADRID, SEPT. 24.

(Private Correspondence.)—His Majesty departed on Saturday afternoon, at 5 o'clock. During the days preceding his departure, great crowds thronged to the Royal residence; not only the Grandees of Spain, and the high functionaries, who went to pay their respects to the Monarch, but likewise a great number of citizens of all classes proceeded to the homage to His Majesty. Groups were forming in every quarter, and the conversation generally turned on the hopes to which the Monarch's determination gave rise. The Infantes accompanied the august traveller, as far as Galapagens. He stopped upwards of an hour at Espartenas, to peruse the despatches brought by an extraordinary courier, who was ordered to go on to Madrid. It is thought, notwithstanding the itinerary in Saturday's Gazette, that His Majesty will stop some days at Valencia, in order to give time to General Romagosa to open the negotiation, for which purpose he has full powers.

On the 21st, at daylight, the remainder of the Horse Grenadiers of the Royal Guard left this for Catalonia.

His Majesty did not depart until he had made the most prudent arrangements for preserving public tranquility from being disturbed during his absence from the capital. M. de Zombrano, the Secretary at War, is charged with the execution of the measures prescribed in case of any disturbance.

M. Caro, the Governor of this Province, returned to Madrid, after having accompanied the King as far as Ocana. His Majesty received every where on his passage, demonstrations of the affections of his subjects.

SEPT. 26.

On the 22d, in the morning, at the moment of his Majesty's departure, some symptoms of discontentment showed themselves at the Escorial; but the people grew calm on finding that the Royal Family remained at that residence, which they would not believe, notwithstanding the publication of the official Gazette.

The Council of Castile, which according to our law, is invested with special power, by virtue of which it may oppose the King's removal from the capital, has not consented to the King's journey. This Tribunal has transmitted to its Fiscals a report made by a majority of two to one, declaring that notwithstanding the Royal will, that Council is entirely a stranger to this journey, and in no wise responsible for the consequences which may be incalculable, when it is considered that the absence of the Army of Observation leaves Estremadura and Galicia unprotected, in which provinces the public mind is most opposed to that of Catalonia. Supposing that the journey succeeds, the Council may still have in this opposition the double object of maintaining its franchises, and to remain unpledged with respect to the new system, to which this journey may give rise.
