MORE OR LESS.

For such quantities of Lamp Oil and Cotton Wick, as may be required for one year from 25th June next, at St. John and Fredericton, to be issued to the Troops in detail by the Contractors.

For such quantities of Fresh BEEF as may be required for one year from the 25th June next, for the Troops and Departments in the Garrisons of St. John, Fredericton, St. Andrews, and Fort Cumberland.

For supplying into the Commissariat Stores at St. John, on or before the 24th day of June next, Twenty barrels of Prime Mess Irish PORK, warranted to keep good and sweet until 24th day of June, 1828.

The Rate of Fresh Beef, Salt Pork, Wood, Coal, Oil, and Cotton Wick, to be expressed in the Tenders in British Sterling, in words at length; and if the amount due upon any of these supplies exceed One Hundred Pounds Sterling, the same will be paid for in Bills of Exchange on the Lords of the Treasury, at the rate of £100 for every £103 due upon the Contractor, in British Silver, at the option of the Deputy Commissary General.

For Baking BREAD, for one year from the 25th June next, for the Garrison of St. John, from Flour to be furnished from the King's Stores. The Bread must be raised with Brewer's Yeast, and the Contractor's Bakehouse to be at all seasonable hours liable to be inspected by a Commissariat Officer.

It is to be distinctly understood, that the Beef to be supplied, is to be of the best Marketable quality.

That no crooked or rotten Wood, or any other but the best quality of Liverpool or Newcastle Coal will be received.

No Tender will be noticed unless accompanied by a Letter addressed to the Senior Commissariat Officer at St. John, signed by two responsible persons, offering to become bound with the party tendering, for the faithful performance of the Contract.

The Tenders to be written on the back "Tenders for Wood, Coal, &c." as the case may be. Persons tendering, or Agents for them, are particularly requested to attend at this Office on the 31st day of May next, at twelve o'clock.
