Circular to the Magistrates of the County of York.

Fredericton, 9th March, 1827.

SATISFACTORY assurances having been conveyed to His Majesty's Government of the earnest wish of the Government of the United States to reciprocate the conciliatory disposition shown in regard to the Disputed Territory, at the upper part of the River Saint John, it is most desirable, until the question relating thereto shall be finally settled, that no new settlements shall be made, or any timber or other trees felled, in the wilderness part of that Territory, nor any act done which may change the state of the question as it existed when the Treaty of Ghent was executed.

I am therefore commanded by His Excellency the Lieutenant-Governor to desire that you will be vigilant and use your utmost diligence to discover any attempts which may be made by any of His Majesty's subjects to intrude upon any part of that Territory with a view to make settlements or to procure timber, and to make immediate representation thereof to His Majesty's Attorney General, that legal steps may be taken to punish such Intruders and Trespassers; and should you discover similar attempts to be made by any other persons whether unauthorized or appearing to act under colour of authority, that you will use your best endeavours to ascertain the names of such persons and report the same to me, with affidavits to establish the facts, for His Excellency's consideration.

DEATH OF THE EMPRESS OF BRAZIL
To the Editor of the Albion.

"SIR.—Though I have seen the death of the Empress of Brazil mentioned in different newspapers, yet never having heard any particulars, or cause assigned for it, I thought my sending you an extract of a letter from a gentleman in Rio Janeiro to a friend in New-York, might prove interesting to you and your friends.

The letter is dated the 11th of December last, and says, "The Empress died yesterday at half past 10 o'clock, much regretted by all around her, by whom she appears to have been much beloved. There are various reports respecting her death: some say she was poisoned; others, that the Countess of Santos struck her with her elbow;—but the story most to be relied on is as follows. A few days before the Emperor started on his present expedition, the Countess of Santos, daughter by the Emperor (who gave her this title) told the Emperor that a favourite servant of the Empress had been impudent to her; on which the Emperor ordered that the servant should receive one hundred lashes. On hearing this, the Empress requested the Emperor to mitigate the punishment, and said that the child was in error, on which the Emperor flew into a violent passion, and forgetting the delicate situation of the Empress, offered her personal violence; which, producing miscarriage, succeeded by morification, caused her death.

The Countess of Santos, who was first lady of honour to the Empress, and at this time, in like circumstances, has been obliged to fly to the Minister of War, for protection, until the Emperor returns: he is momentarily expected, as three vessels, and as many messengers were immediately despatched for him. Meantime, the Empress is dressed in state, and placed in a chair for all the subjects to express their devotion to her, by kissing her hands, &c. The forts and vessels in the harbour, have been firing minute guns ever since 5 o'clock last evening. The people are much incensed against the Countess, and say they will kill her, as she has been the cause of the death of the Empress."

Distressing Occurrence.—On Thursday the 5th instant, Mr. Abraham Newkirk, Mr. John Greenman, and a Mr. Fish, were unfortunately drowned in attempting to cross the Schoharie creek in a skiff, at the ferry at Fort Hunter, five miles west of Amsterdam village. Mr. Greenman and Mr. Fish immediately sunk in the flood, in the presence of Mr. Greenman's wife and children, and a great number of spectators, and were not seen to rise. Mr. Newkirk arose, swam about 40 rods and went over the dam just below the ferry; he was followed by his wife on the bank until he arrived on a shoal, for which he evidently directed his course; on it he raised himself about half out of water, beckoned to his wife, was swept off, sunk, and seen no more!—*N. Y. Statesman.*
