

unprecedented number of Noblemen and Gentlemen, Members to the institution, or connected with Agriculture. It appears by the list of Premiums, that the greatest encouragement is there given to the production of the improved Short Horned Cattle, and Dishley Breed of Sheep. This we particularly notice, as it furnishes a strong proof of the wisdom of our Central Agricultural Board, in importing animals of those kinds, and also as the number already introduced, and possessed, is a matter of congratulation to the people of the Province, generally. We hope the Central Society will persevere in extending those species still more generally throughout the Counties. We also notice with pleasure, the great care taken to obtain Seeds of the first quality—a matter heretofore much overlooked in this Province.

After the Meeting alluded to, about 300 Noblemen and Gentlemen sat down to dinner, and it affords us much satisfaction to observe, that our Agricultural Institutions were flatteringly noticed upon the occasion, which was duly acknowledged by the Secretary of the St. John's Agricultural and Emigrant Society, who was present; and we are happy to find, devoting himself to the acquirement of useful information on the subjects connected with his office.—Admiral Sir D. MILNE, rose and said—That Agricultural improvement was not merely confined to this Country, but that Societies for that purpose had been established ten years ago in Nova Scotia, and that there was now in the Room, a Gentleman who was Secretary to one in New-Brunswick. He therefore proposed the health of Mr. WEDDERBURN, and the New-Brunswick Agricultural Association, which was given with three times three.

Mr. WEDDERBURN, in returning thanks, said—That the high but unexpected honor just conferred upon him, as a Stranger and Member of an Agricultural Society in British North America, demanded his best acknowledgments, and were his abilities to make them equal to the feelings which the kind and flattering manner his health had been given and received, excited, they would be expressed in a proper manner; but that not being the case, he would merely beg to assure his Lordship and the Society, that the eyes of Colonial Agriculturists were turned with intense interest to the proceedings of this Institution, as setting before them the brightest example of agricultural amelioration.—That it was a circumstance not a little creditable to our country, that to the patriotic zeal of distinguished Scotchmen, the American Colonies were indebted for the establishment of those Beneficial Societies, which the gallant Admiral had so kindly mentioned; men who having by their talents and their swords gained laurels for themselves, and peace for their Country, in the war of the Peninsula, had been selected by our gracious King to promote the welfare and happiness of his faithful Colonial subjects.—When he returned to those distant regions, it would be his duty and his pride to relate to those Societies, the enthusiastic manner in which his health and their welfare had been drank. And in returning thanks in their behalf, he hoped that year by year the prosperity of this Institution might extend, until the blessings it was diffusing, reached every portion of our common and beloved Country and that every Son of Britain, whether resident in His Majesty's Foreign Dominions, or in the bosom of the Empire itself, might emulate in loyalty and patriotism, the HIGHLAND SOCIETY OF SCOTLAND.—(Loud Cheering.)
