VACCINATION.

It is with much satisfaction we lay before our readers the following Communication, with the paper alluded to therein; and we deem them to be eminently entitled to the most serious consideration. The Public cannot be too thankful to HUMANITAS, for the interest he has manifested in their welfare, in thus bringing, in so able a manner, the important subject of Vaccination under their notice. The paper alluded to in HUMANITAS' Letter will be found on our last page.

MR. EDITOR.

That loathsome and dangerous disease, the Small Pox, having lately existed in our sister Province; and as yet, we being enabled to congratulate ourselves, under Providence, on our exemption from it; your pages I presume might be usefully occupied in transcribing the enclosed. The paper is valuable, in as much as it contains, the just remarks and sterling truth of a highly re-

spectable Gentleman in his profession; who (being one of the public Vaccinators in England) has by minute investigation, done much towards the upsetting of that popular prejudice, and contagious incredulity, to which thousands have fallen victims—introducing in their stead an unvarnished collection of facts, which he who runs may read, or he who has common sense may understand and give full credence to. I am induced to offer one or two prefatory observations, from the knowledge, that there are at present in this Town, a great number of persons, particularly Emigrants and their families, who either have not had the Small, or cow Pox; or are utterly ignorant as to the circumstance.

This fact undoubtedly calls for immediate and peremptory consideration; and as the Executive of the Province are now in Council and Assembly, I should trust the Session would not be terminated, without the deepest consideration on a matter of such infinite importance; one indeed, which (independent of the claim of common humanity) invades the dearest and nearest interests of our own domestic hearths; one that most intimately concerns the welfare (I would almost add the existence) of the Country at large; for where this former scourge and horror of the human race for centuries past (even as far back as the Saxon period of our history,*) once to make its ravaging inroad, the sacrifice of life might be so appalling, as to depopulate one third of the Province.

In the Mother Country, public Vaccinators are appointed under the Authority of Government, who receive an annual and moderate compensation for the trouble they have, and the benefits they distribute. These Gentlemen keep a regular half yearly account of the patients they vaccinate, and transmit the same to the General Board—Hence obtained many of those satisfactory conclusions which the enclosed paper affords.

Where the highly respectable talent of the Province is concentrated, as in the present season; to offer or dictate a plan of similar management would be presumptuous in an Individual; but I may perhaps be allowed to state, that, as a preventive cause is at least equal a remedial effect, it would be no trivial object in view, to take care that no future Emigrant should be considered an inhabitant of this country, till it was satisfactorily proved by medical examination that he had been vaccinated, or had had the small pox either in the natural way, or by Inoculation.

* It has been conjectured by some of our earliest writers, that this dreadful malady was brought into England about seven hundred years ago, by our countrymen returning from their wars in the Holy Land, but there can be little doubt that it existed here before that period. As it made its appearance in Europe so early as the eighth century, when it is said to have been first introduced into Spain, by the Moorish Army, led by Count Julian; who, in revenging his private quarrels with Rodric, the last of the Gothic Kings of Spain, became the occasion of communicating this fatal disease to his fellow countrymen, and from them, it was quickly propagated among other European nations. On the discovery of America by Columbus, his followers carried the disease among the Indian nations of that continent, and for want of knowledge as to its proper treatment, it spread like a Pestilence wherever it appeared."
