## COMMISSIONERS OF ROADS.

## City and County of St. John.

The last English dates are to the 15th March. It appears that Russia has made a separate declaration of War against Turkey, the cause of which is said to be founded on the non-fulfilment of the treaty of Ackerman, on the discovery of a secret treaty between the Turks and the Persians, and on the tone of defiance adopted in the Turkish manifesto itself.

The Porte had not come to any open rupture.

## LONDON, MARCH 15.

RUSSIA AND TURKEY.—A Russian Messenger, and a French one, arrived this morning. The week is closing upon us, and leaves us in a state of great anxiety for the next arrivals from that which, if not already become the seat of war, is likely to become so immediately. The Russians, after crossing the Pruth, are expected to stretch along the north bank of the Danube, and thus prevent the Turks from drawing supplies, or oppressing the inhabitants of Moldavia and Wallachia. The Turks will confine themselves to the southern bank of the Danube.

It were an act of injustice to the Court of Vienna, were we to neglect paying her that tribute which she well deserves from us at the present moment. Whether Turkey be inclined to listen to more moderate counsels is a question, which, it is obvious, we are not yet able to answer. But we feel a thorough conviction that the Court of Vienna has always been desirous of preserving peace, and is most anxious at this moment to bring the Turks to reason. This is one subject of congratulation—another is that a complete union and cordiality exist between France and England—and that the past conduct of Russia affords the best security against any misunderstanding between the European powers.—*Courier.*

In the present state of affairs it will not surprise our readers that Cabinet Councils are held daily. One was held on Saturday—another yesterday—and one was sitting when our paper went to press.

It appears from the Paris Papers that the French Government is actively employed in sending troops, stores, and ships, from Brest, Marseilles and Cadix, to Toulon, which will be the general rendezvous. The number embarked at Brest will be 3,000, and the whole will exceed 12,000 men. But we fear some damage has been done to the French transports sent to Cadix, 14 of which are said to have perished in a storm.

Dispatches arrived on Tuesday at the Colonial Office, brought by the George the Fourth, Capt. Black, R. N., which left Lisbon on the 12th inst. The despatches from Sir William Clinton, G. C. B., commanding the British Army in Portugal, are dated the 8th. A confirmation has been obtained of the proceedings of Don Miguel, and of the manner in which he appears to be influenced by the Queen and the violent fanatical party. All the British troops would be embarked by the 24th inst.

Sir C. Weiherell, re-appointed Attorney-General, took the oaths and his seat on Wednesday afternoon.

We understand that a gentleman (Mr. William Dunbar,) of Charlton, in the Bay Chaleurs, reached town on the evening of the 7th inst., after a very short trip on foot overland. On the 29th March he left home, and on the 2d instant at noon reached Miris. The rate at which Mr. D. performed this journey may be estimated at 40 miles a day, which when it is known that a part of the distance is ever a wild and uninhabited country, without a road or footpath, and the whole deeply covered with snow, may be considered extraordinary travelling. This affords strong proof of the facility with which a road connecting this Province with New Brunswick, may be made on the line already partly traced between Miris and the Restigouche, to a point on which latter River, the other Province has already brought a new road, with the express view, as we are informed, of connecting the communication with Lower-Canada.—*Quebec Gazette by Authority, April 10.*

We understand that His Excellency Sir James Kempt has received orders to repair immediately to Canada;—the object of his mission is said to be to inspect the new fortifications. His Excellency will leave town for Pictou on the 17th May, and the Chebucto is to call there for him.

The Editor of the St. John *Courier*, in a recent number, favoured his readers with what he very appropriately intitled an "Instance of Strength," in the person of John Horsford, an old Settler at Quaco, aged 96 years, who travelled, it appears, from Mr. Wilmot's farm to the City of St. John, a distance of twenty miles, between seven o'clock in the morning and four in the afternoon. The Editor further acquaints us with an interview he had with Mr. H., during which he ascertained that that person "has been the father of twenty-four children, the youngest of whom, now alive, is seventy years of age." How this business was managed, or in what particular way our friend satisfied himself upon the point, seems to us no simple matter to resolve; for at that rate, according to our calculation, the eldest, if living, must be pretty near the age of his own father, which, undoubtedly, is a most extraordinary circumstance.
