PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the sixth year of His present Majesty's reign, intituled "An Act to regulate the trade of the British possessions abroad;" it is, amongst other things, enacted, that certain ports, therein particularly mentioned, in the island of Jamaica, and in the provinces of Nova Scotia, Canada, and New-Brunswick, and in the island of Barbadoes, shall be free warehousing ports for the purposes of the said Act; and it is further enacted, that it shall be lawful for His Majesty in Council,
