

and peculiar manner of the Author; Consider the context of the passage, and the scope of the whole subject—and then apply to Whitby, Locke, or M'Knight, and see how they have explained the Paragraph. Sometimes you will find that these Authors have elucidated what was dark and unfolded, what was before intricate and perplexed; and at other times you will be confirmed in your previous opinion, though it may differ from that of any Commentator. Thus you will gradually acquire a manly confidence in yourself, and get rid of that implicit reverence for great names, which has been so hurtful in most departments of Literature; but in none more than in this. And there is no fear that this will produce an arrogant and dogmatical spirit, if you study with simplicity and earnestness, and pursue Truth in the love it.

Let me earnestly urge upon you both, diligence in your Studies. Nothing but Industry and Labour can make a Scholar. To repeated and persevering efforts, every obstacle, however formidable at first sight, may appear, must finally give way. It is the Law of Nature, which is the Law of God, that human improvement is always in direct proportion to the labour employed, and to the exertion of the faculties in any pursuit. Dr. Blair has justly remarked, that Industry is the appointed vehicle of every good to man; without it we may possess, but we cannot enjoy. And, whatever knowledge you may acquire, make no parade, nor ostentatious display of it. All real excellence rests upon itself, and therefore is modest and unpretending. The man who is conscious that he is actuated by principles of integrity and of honor, will not go about proclaiming that he is a man of integrity and of honor; he will wait until his Neighbour repose confidence in him, until he depend upon his friendship and rely upon his veracity; and then his Light will shine forth to the glory of God, the edification of men, and to his own real honor and lasting reputation. Thus, if you be possessed of real knowledge, you will be conscious that you do possess it; and if your conduct be virtuous, every man whose opinion is worth being solicitous about, will esteem you; your knowledge will set easily upon you, and whenever you are called upon to make any display of it, you will do it gracefully and unconstrainedly; not with the affectation of a Pedant, and the arrogance of a Pretender, but with the modesty of a Scholar, the charity of a Christian, and the courtesy of a Gentleman.

But above all things, consider the awful responsibility to which you are liable for the benefits of Education bestowed upon you. Whether five Talents, two Talents, or one Talent be committed to us, they are the Deposit of the Great God, the Sovereign Lord, and Absolute Proprietor of Heaven and of Earth. They are a Loan that is lent, given to us to improve, during the short time allotted to us, for probation here below. Call often to mind the horrible doom of that unprofitable Servant, who, instead of trading with his Master's money, hid it in the earth, so that his Lord at his second coming received not that usury which he had a right to expect. Whatever abilities, natural or acquired, you possess, use them so far as you can, to the benefit of Society in general, and of your Neighbour in particular. For be well assured, that you can never employ your faculties more agreeably to the Will of the Gracious Donor, the Author of every good, and of every perfect gift, than by endeavouring to the very utmost of your power, to promote the welfare of your fellow creatures.
