COMMISSIONERS OF ROADS.

Hugh J. Hansard, Esquire, to expend the sum of £1000 on that part of the road from Fredericton to Peticodiac which lies between Fredericton and the head of the Grand Lake.

The Honorable A. E. Botsford to expend £1000 on that part of the road from Fredericton to Peticodiac which lies between the head of the Grand Lake and Peticodiac; and to be Commissioner for the proposed road from Sackville to the Nova Scotia Line, across the Tantamar Marsh.

Elisha Peck to expend £200, granted for the road from Hammond River to Hopewell.

James Albee to expend £60 granted for the improvement of the Great Road from Connick's at Waweig to the lower Bridge in Saint Stephen's; and

The sum of £25 granted towards completing a Steamboat Slip at Saint Stephen.

Patrick Clinch to expend £200 granted to open a new road from Red Rock, in the Parish of Saint George, to the Nerepis Road.

James Brown to expend £100 granted to open a road from the Bridge at Brockway's, to the lower Bridge over the Saint Croix.

Jacob Allen to expend £500 granted for opening and improving the new line of road from Oak Bay to the Bridge at Eel River.

John Jordan and Philip Palmer to explore a proposed new line of road between the head of Bellisle Bay and Kingston, as contemplated by E. G. N. Scovil, Vincent White and others, and also to survey the present road between those two places, and explore some minor alterations proposed therein: towards the expense of this service, the sum of £50 has been granted.

James Ketchum and George Hayward, Esquires, to be Commissioners for making Contracts for the Bridges requisite on the line of road between Fredericton and Woodstock, as explored by James A. MacLauchlan, James Brown, and Asa Dow, Esquires, on the west side of the River Saint John.

Valentine Gibbs to expend the following sums:

£80 for the road between Pokemouche and Tracaday.

£15 for a Bridge to be erected over Lousier's Creek.

£45 for the Caraque Lower Portage.

£45 for the roads connected with the Shippegan Settlement; and,

£40 to be expended on that portion of the Bye Road containing the Settlements of Saumarez and Alnwick in the Counties of Gloucester and Northumberland, which hitherto has not been under the Supervision of the Bye Road Commissioners of either of those Parishes.
