CAP. XLV.

An Act to continue the Acts relating to Highways. Passed 25th March 1840.

BE it enacted by the Lieutenant Governor, Legislative Council and Assembly, That an Act made and passed in the fifth year of the Reign of His late Majesty King William the Fourth, intituled "An Act to repeal all the Laws now in force for regulating, laying out and repairing Highways and Roads, and for appointing Commissioners and Surveyors of Highways in the several Towns and Parishes in the Province, and to make more effectual provision for the same;" and also an Act made and passed in the sixth year of the same Reign, intituled "An Act in amendment of the Act relating to Highways," be and the same are hereby continued and declared to be in force until the first day of April which will be in the year of our Lord one thousand eight hundred and forty two.

CAP. XLVI.

An Act to extend the provisions of the Fourth Section of an Act, intituled "An Act to amend the Act to provide for the Collection of the Revenue of the Province," to Woodstock in the County of Carleton.

Passed 25th March 1840.

THEREAS it is desirable that the Deputy Treasurer at 'Woodstock, should, under particular circumstances 'have power to appoint a Deputy;'
