It was highly pleasing to all those who are connected with the College to observe that, while none of the branches of instruction appeared to have been at all neglected, the wish of the College Council-that particular attention should be paid to mathematics-had been very diligently and successfully attended to. In that subject several of the elder Scholars bore a long questioning from Mr. Professor Jack, both in Algebra, and ir Geometry, including Trigonometry, so as to draw forth commendation from that Gentleman, in which all present seemed fully to concur.

The monthly inspection of this School by a Committee appointed by the College Council, consisting of the Professors of the College and other Gentlemen, appears to have produced the good effects anticipated from it. GEORGE F. STREET,
