QUEBEC, September 16.—The Port of Quebec presented an appearance yesterday, which we wished had been seen by all those who live on the waters of this Great River, of which Quebec is the natural outlet to the sea. There were about two hundred square rigged vessels, chiefly just arrived, anchored in the stream between Cape Diamond and Point Levy; and still they were nothing compared to those which might find a safe harbour in the port. We can assure all our distant friends, whether they live on the waters of the Great Lakes or of the British seas, that we can accommodate them all, in effecting the exchange of commodities, and "the more the merrier."—Gazette.

BOSTON, September 19.—MAINE ELECTION.—All the accounts from this State seem to confirm the news of a Whig triumph at the election on Monday last. There is no longer any doubt that Edward Kent has been chosen Governor by a majority of 6 or 700 over Governor Fairfield. In the Senate 17 or 18 Whigs (of the 24) are elected.—There is also a Whig majority in the House. Of the Members of Congress the Whigs are known to have elected four, and another (Mr. Noyes) probably, out of 8.

HON. J. Q. ADAMS.—We take great pleasure in announcing the safe return of our distinguished fellow citizen, the Hon. J. Q. Adams. He reached this city at noon, with his son and Capt. Nathaniel Curtis, in excellent health, after a very pleasant journey, during which he received the most marked attention and respect (not only from the gentlemen, but also from the ladies) in the British Provinces, and in the States of Maine and New Hampshire. At Bangor and at Portland he addressed large audiences, and gave a grand blow up to the Sub-Treasury. On the Boundary Question, he shed some light in his incidental conversations with the British authorities, which, we trust, will not be lost.—Evening Gazette.

The Great Western Rail Road from Boston to Albany is progressing rapidly. Not less than 2,000 men are employed upon it, in some sections, both day and night. When that is completed, the struggle for the business will produce a competition between the cities of Boston and New York.
