MILITIA GENERAL ORDER.

With reference to the Militia General Order of the 16th November, 1840, (requiring Officers Commanding Battalions to furnish the Quarter Master General of the Militia Forces, with correct returns of the number, state and condition of the Arms and Accoutrements in possession of their respective Corps,) it has been found that many cases of omission have occurred.

Commanding Officers of Corps therefore who have failed to comply with the Order above alluded to, are required forthwith to send in their Returns, in order that the Quarter Master General may be enabled to prepare a General Return of all Arms and Accoutrements belonging to the Militia, for the information of the Lieutenant Governor, preparatory to the approaching Inspection.

Commanding Officers will also report whether they have caused to be erected any and what places of safe deposit, (or Arm House,) for the reception and security of the Arms.

LATEST FROM ENGLAND.

Since our last publication another of Cunard's successful line of steamers, the *Britannia*, has arrived at Halifax, in 134 days from Liverpool, furnishing us with our usual supply of English and Scotch papers. We do not perceive much of importance beyond the contents of the following brief summary:—

Parliament adjourned for the holidays, on the 6th. The House of Lords met on the 22d inst. and the House of Commons on the 20th. The Budget shows a great decrease in the public Revenue.

STEAM!—The Royal West India Steam Navigation Company have determined to build six additional Steamers. They will be contracted for by the Cunard Atlantic Steam Co.

THE PRESIDENT NOT ARRIVED!—Great uneasiness is felt on account of the non-arrival of the President up to the hour on which the *Britannia* left.

France is dreaming on the excellencies of the Fortifications Bill.

Switzerland is still unsettled.

Spain is discussing the Regency Question.

Belgium has become subject to a new administration.

Portugal is agitated by intrigues for power.

LIBERILITY OF PRINCE ALBERT.—Prince Albert has been munificent: he has given the Nelson Monument Committee a hundred guineas towards the cost of the monument: and he has presented the Commanders of each of the three Vessels of the Niger expedition with a handsome gold pocket chronometer, made by the best London makers, and inscribed with the name of the giver and the receiver.

York Minister is far from being restored since the fire. Nearly the whole of the £13,000, collected by subscription has been actually expended, or appropriated to works in progress towards completion. The works remaining to be executed, and for which no provision yet exists, are estimated to cost little short of £10,000.

Wood, the vocalist, left the packet ship *Washington*, when off Wales, and landed at Milford, whence he posted to London, with his shares of the United States Bank in his pocket, all of which he sold at 60. The *Washington* reached Portsmouth two days afterwards, with the news of the stoppage of that institution. This is "coming Yorkshire" with a vengeance.

COMMODORE NAPIER.—This gallant officer arrived at Liverpool in the steam ship *Oriental*, on his return from the Mediterranean, and was entertained at a public dinner in the Amphitheatre, on Monday the 19th April.

We regret to state that no intelligence of the steam ship *President* had reached England when the *Britannia* left. The President was then out nearly 40 days from New York.

The rate of insurance paid on the President at Lloyd's yesterday was from 40 to 50 per cent.

RAILROADS FOR IRELAND.—A number of English capitalists, at the head of whom are the Messrs. Baring, have come forward with the necessary funds. They are to be secured by the government at a certain per centage on their outlay.

Lord Brougham was admitted to a private audience of the King of the French on Tuesday.

Among the passengers on board the President steam ship, whose non-arrival has excited so painful an interest, is Lord Fitzroy Lennox, second son of the Duke of Richmond. His Grace and family are now at Goodwood, where the deepest anxiety prevails. His Lordship was on his return home to join the 13th Dragoons, into which he had recently exchanged from an Infantry regiment stationed in Canada. —*Brighton Herald.*

The first cargo of sugar from the Mauritius to Waterford, arrived a few days since.

Upwards of 4000 persons visited the British Museum on Easter Monday.

Messrs. Wakefield and Son, London stock-brokers, have absconded, leaving a deficiency of £73,000, the loss of much of which sum will fall upon ladies who had entrusted their property with these parties.

CHRISTIANITY IN CHINA.—There are about 300,000 Christians in China. They are not allowed to practise their religion publicly. There is, however, still existing in Pekin a church erected by the Emperor Hang Hi, who was very friendly to the Christians, and a notion has long prevailed among the Pagans of China, that as long as the cross remains standing on the steeple of the church, no serious calamity can befall the empire. In Canton there are between 8000 and 9000 Christians.

SIR DE LACEY EVANS, M. P.—A piece of plate has been presented to this officer, in fulfilment of a resolution entered into in Spain by the whole of the generals, colonels, and two hundred officers, who remained with the Legion to the close of the operations under his command.

The King of Hanover has given directions for the dismantling of his apartments in Saint James' Palace; waggon loads of valuable articles are daily sent off.

Father Mathew, in a recent progress through the north of Ireland, made 2000 proselytes while changing horses at Athbon.

THE BANK OF ENGLAND.—The loss sustained by the Bank of England on discounting acceptances amounting to forty millions sterling, does not exceed twopenny halfpenny per cent.

HIGHLY IMPORTANT FROM CHINA.

The British squadron have reduced the two best of the Chinese Forts, and blown up a large number of their Junks. The war was going on with great activity, when the Chinese Commander in Chief made a communication to Captain Elliott, who thereupon desisted from hostilities.

The following are stated as the terms for peace which had been entered into between the late belligerent authorities:

"1. The cession of the Island and Harbour of Hong Kong to the British Crown. All just charges and duties to the empire, upon the commerce carried on there, to be paid as if the trade were conducted at Whampoa.

"2. An indemnity of the British Government of \$6,000,000, \$1,000,000 payable at once, and the remainder in equal annual instalments, ending in 1846.

"3. Direct official intercourse between the two countries upon an equal footing.

"4. The trade of the port of Canton to be opened within ten days of the Chinese New Year, and to be carried on at Whampoa till further arrangements are practicable at the new settlement. Details remain matters of negotiation."

Mrs. Barker had been a member of the Baptist church for nearly forty years, and her piety and deportment through life manifested to all around her, that she had been with Jesus. Retaining her mental faculties to the last, she died in full assurance of a blessed resurrection among the just.

REGULATIONS AND CONDITIONS.

1st. That the upset price on each Lot be £50 (fifty pounds), and the whole amount of the purchase money on each lot to be paid on the day of sale to the Receiver General, or other person authorized to receive the same.

2d.
