That Mr. Edward Master be recommended as Agent for the Road and District via third. Loch Lomond Lake, towards Hammond River,



MAY IT PLEASE YOUR EXCELLENCY,-

I beg leave to report for the information of Your Excellency, that I have recently explored the line of country from the entrance of the Schoodiac or Saint Croix, along the reputed American Boundary, to the River St. John.

The rocks from St. Stephens to the lower Cheputneticook Lake, were found to consist of varieties of Granwacke and Slate. These rocks are met by a tract of Granite, occupying an extensive area, reaching in a northeast direction from the Cheputneticook Lakes, to the St John, at the Meductic Falls and Pokiok.

The most interesting minerals discovered in this exploration, are sulphuret of Iron and Copper Pyrites, which occur between Eel River and Woodstock. Almost the whole of the ceeding month, at the semi-monthly meeting compelled to encamp every night during a fortnight.

The wild and ungranted lands situated between the Saint Croix and the Magaguadavic, are nearly all capable of cultivation, and at many places the soil is of a superior quality.
