A PROCLAMATION.

WHEREAS a Proclamation, bearing date the twenty ninth day of July last, was issued, commanding all Persons who have illegally occupied any Lands reserved by the Crown for the benefit of the Indians, forthwith to quit the same, and to abstain from cutting or removing Timber therefrom; And whereas it is expedient furthermore effectually to prevent the infraction of the prohibition; I do therefore hereby require and strictly command all Persons whatsoever to abstain from cutting or removing any Timber from the said reserved Lands without Licence, or from otherwise trespassing thereon upon any pretence whatsoever; And I do further require and command all seizing Officers to be vigilant in detecting any trespasses that may be committed on any of the said reserved Lands, and promptly to seize all Timber that may be found to have been cut thereon, without Licence for that purpose first obtained.

A PROCLAMATION.

WHEREAS a Proclamation, bearing date the twenty sixth day of July in the year of our Lord one thousand eight hundred and thirty seven, was issued by the Lieutenant Governor, forbidding all persons from occupying any part of the Wild Lands within this Province, comprehending the Territory in dispute between Great Britain and the United States of America, known under the denomination of the *Disputed Territory*, of trespassing thereon by cutting Timber or otherwise; And whereas by another Proclamation, bearing date the twenty second day of October in the year of our Lord one thousand eight hundred and thirty nine, this prohibition was repeated, and the Warden of the said Territory was duly appointed and authorized to arrest, seize, take and destroy all Timber which might be cut in violation thereof; And whereas it is deemed necessary that the aforesaid prohibition should continue to be strictly enforced; I do hereby call upon and direct all Peace Officers and other Lieve Subjects of Her Majesty within this Province to be aiding and assisting in enforcing the same, and also in effecting the seizure of any Timber cut in violation of the aforesaid Proclamations by any persons whatsoever.

WHEREAS representations have been made to His Excellency the Lieutenant Governor, that Licenced Teachers of Parish Schools, who have either relinquished the Schools in which they have been employed, or have been dismissed therefrom, and, under their present Licences, have frequently sought employment, as Teachers, in other parts of the Country, where they were unknown, and this, without any explanation of the causes of their removal;—His Excellency is pleased to prohibit this practice in future, and to direct, that Licenced Teachers, leaving a School in which they have been engaged, and seeking employment as Teachers elsewhere, shall procure from the Trustees of the School, in which they have been teaching, a certificate specifying the reasons of their leaving, and stating what their conduct had been during the period of their employment; which certificate and testimonial shall be exhibited to the Trustees with whom they propose to make a new engagement; and, in case of removal to another County, also to the Board of Education in that County, before whom they are required to be re-examined, as to their fitness for the office of Teacher; and the Licence of any person who shall be found to have infringed this Regulation, to which the particular attention of the several Boards of Education and Trustees of Schools is invoked, will be considered as cancelled.

KING'S GENERAL SESSIONS, 2 OCTOBER TERM, 1841.

Regulations respecting Tavern-keepers within King's County.

Ordered, That the following Rules and Regulations be established for the government of Tavern-keepers in King's County, in addition to those made at the last March Term.

1st. Every Tavern-keeper shall cause to be put up and kept over his door, or on some conspicuous place outside of his house, a Board with his Christian and Surname at full length, and the words, "LICENCED TAVERN" legibly painted thereon, under the penalty of *Forty Shillings*.

2d. Every Tavern-keeper shall at all times keep, and when required furnish Travellers with necessary refreshment, bedding and accommodation, and in addition to the liquors usually provided, shall also furnish, if required, Tea and Coffee, with Sugar and Milk, and also good Malt, Spruce or Ginger Beer, or Cider, under the penalty of *Ten Shillings*.

3d. Every Tavern-keeper shall have sufficient Stable room for the accommodation of at least Four Horses, with a proper place of security for the Property, Sleighs, Sleds, Carriages and other vehicles of Travellers, and shall at all times keep a sufficient supply of Hay and Oats, with a competent person to take care of, feed and groom Horses, under the penalty of *Twenty Shillings* for every default.

4th. No Constable or Tavern-keeper shall be taken as a security for a person to whom Licence shall be granted.

5th. Every Tavern-keeper shall cause a Copy of these Regulations to be posted up conspicuously in his Public Room, and there continued, under the penalty of *Forty Shillings*.
