The most serious difficulty has been likely to arise from the great number of squatters who had settled upon ungranted lands, a list of which, with brief notes, is appended to this Report. A number of these had cleared lands, built houses, and made themselves comfortable, others have only felled and burnt from one acre to four acres, and a few had expected to hold occupation by cutting down a few trees, after an order had been issued to survey the whole Tract. Under a consideration of these circumstances, it was deemed advisable to allow such persons to join the associations. It is desirable that the survey of every tract should be completed before settlers enter upon the lands. Firmness is also required on the part of the Surveyors, in order that the general good of the whole may not be sacrificed for the benefit of a few. No possession should be given of the reserved lots. Should the lots sold on credit, never be paid for, the increase in the value of the reserved lots by the adjoining clearings, roads, &c. will be more than a four-fold compensation to the Government for all the lands thus disposed of.

When any body of Emigrants or persons from the Towns associate to open a new Settlement, jealousies immediately arise between them and among the inhabitants near the Districts selected for settlement. To remove this evil, encouragement should be given to the young men of the Province to mix with the strangers, and this will prove a certain and an effectual remedy. The labors of an efficient and zealous Emigrant Agent or Commissioner, are, in my opinion, highly necessary in the opening of new Settlements in the Province.

A plan of the Settlement, with another Report, will be laid before your Excellency as soon as the Surveys are completed.

The following Prospectus was read and adopted at a Meeting of the Ladies Benevolent Society held yesterday at the Government House:—

A S the approaching Winter is likely to be one of more than ordinary suffering to the Poor, owing to their being unable to procure employment or to make provision for themselves and Families; and as the number of the destitute will probably far exceed that of many past Seasons, it is most desirable that a combined effort of the Inhabitants of Fredericton and its vicinity, should be made without delay, to meet the exigency of the case, under the superintendence of the "Ladies Benevolent Society," in addition to its ordinary operations.

Though the Friends of this Institution have reason to apprehend that some unworthy objects were receivers of its bounty during the past Winter, yet they are confident that a much larger proportion of really deserving Poor were satisfactorily relieved; and they trust, that, by the blessing of Divine Providence, it may still be the means of doing increased good under the plan now proposed.

It is intended to confine its operations principally to supplying Food to the very destitute, and such proportion of Clothing as its

funds will admit of, aided by contributions in kind.

In this view it is proposed to procure a supply of Potatoes, Oatmeal, and other Provisions, and to deposit these articles in some central situation, from which they may be issued as occasion may require.

An earnest appeal is to be made to those persons in Fredericton and its neighbourhood, whose labours have been blessed so abundantly in the late Harvest, calling upon them to aid in carrying out this Plan by Donations either in Money or Provisions; and the like appeal to be made to all other Persons, to contribute either in Money or in such articles of Clothing as may be useful to the Poor.

Contributors desiring it will be furnished with Tickets of Relief to the value or amount of their respective Contributions, and thus will be enabled to be the dispensers of their own charity.

It is believed that the adoption of a systematic plan of relieving by Tickets, would tend in a great degree to check imposition, as the Applicants would then all be relieved by one person who would be able to prevent an undue apportionment to any single Individual, and in cases of fraud or imposition, to report the ease to the Committee and to the Contributor who may have given the Ticket.
