COUNTY OF SUNBURY.

The following Address was presented by the Grand Jury, to the Honorable Mr. Justice PARKER, at the Court of Oyer and Terminer for the County of Sunbury.

ADDRESS:

TO HIS HONOR MR. JUSTICE PARKER,

The Grand Jury of the County of Sunbury beg leave respectfully to thank your Honor for the charge you was pleased to deliver to us at the opening of the Court of Oyer and Terminer and General Gaol Delivery yesterday, and to express our unanimous feelings of gratification at first meeting you on official duty, and our sincere hope your Honor may long continue to preside in a situation, the duties of which have been performed in a manner to call forth sentiments of great respect and confidence from the inhabitants of the Province.

Your Honor's remarks respecting this ancient County and its inhabitants we have heard with much satisfaction and pride; and the confidence in which your Honor has spoken of the disposition of the Queen's Government to support and protect us, causes in our breasts a continual degree of pleasure in pursuing a steady course of duty under the Government which ever has, and we have no doubt always will protect with British Laws the subjects over which it holds its mild and paternal power.

Grand Jury Room, 23d Feb., 1842.

REPLY:

MR. FOREMAN AND GENTLEMEN OF THE GRAND JURY,

I beg you will accept my thanks for the mark of attention you have so kindly shown me on this, the first occasion of my presiding in this Court.

Fully aware of the serious charge which the judicial office imposes, I cannot but often sensibly feel how inadequate is my performance to my estimate of its requirements, and happy shall I be if by a faithful and diligent discharge of my duty, I can merit and preserve the confidence and respect of the public, which it is important a Judge should possess, in order that the administration of Justice may be no less satisfactory than it is indispensable.

In regard to the observation contained in my charge, I was fully convinced that no where they would meet with a warmer reception or more heartfelt response than in this County.

We ought indeed, Gentlemen, often and seriously to reflect on the vast benefits we derive from the fostering care, protecting arm, just government and noble liberality of the Mother Country. We ought to encourage in our own breasts, and implant and cherish in those who are growing up around us, that sentiment of loyal attachment to our Sovereign which is perfectly consistent with a spirit of enlightened liberty; those feelings of affectionate gratitude for the blessings we enjoy in the possession of English Laws and English institutions, in the public and regular administration of justice, trial and inquiry by Jury, and in representative and mixed Legislation.

This Province more than any other has been founded

on the strong principle of attachment and adherence to the Mother Country; this proved the solace and support of those who have preceded us, this makes the common tie which binds us together; and well may we entertain a just pride, in our connexion with that great Empire, which stands pre-eminent among the nations of the earth.
